Whereas the SFSS President and VP University Relations, as well as the GSS Director of External Relations, have been in talks with SFU regarding its annual budget development process, possible options for future tuition hikes and affordability measures, and relevant information regarding such; Whereas SFSS Board members and staff have concluded that student input into this process has not materially impacted the specific tuition options for the upcoming academic year that the SFU administration has publicly announced;

Whereas SFSS Board members and staff have concluded that SFU has not and will not release sufficient budget information for the SFSS to determine if viable alternative budget choices exist, or if the choices made by SFU reflect adequate consultation of the student body and consideration of its priorities;

Whereas discussions with SFU regarding the upcoming year's budget plan, tuition hikes and affordability options have reached an impasse;

Whereas the SFSS Board of Directors last year chose to endorse the Tuition Freeze Now campaign, with the caveat of supporting 2% increases on domestic students;

Be It Resolved That the Board of Directors call for a tuition freeze at SFU for the upcoming 2020-21 academic year, due to a lack of sufficient information provided to the student body, either directly or through its elected representatives, about the proposed budget, its increases in tuition and fees, and the choices made over alternative possibilities;



Be It Further Resolved That the Board of Directors support a call for a long-term SFU Student Affordability Plan to be enacted as part of the annual SFU budget development process, and for a more robust and improved annual budget consultation process.

# BRIEFING NOTE

Amendment to Commitment Letter for SUB Financing

# Issue

It has become necessary to amend the Commitment Letter that is between the SFSS and Scotiabank regarding financing for the student union building.

# BACKGROUND

In 2015, the SFSS obtained financing for the SUB from the Bank of Nova Scotia (Scotiabank) for construction of the student union building. The details of the financing arrangement were captured in a Commitment Letter that was signed by both parties in December 2015.

As a result of delays in SUB construction, in December 2018 the Commitment Letter was amended to extend the closing date of the construction loan from December 31, 2018, to September 30, 2019.

# CURRENT STATUS

The financing timelines are on schedule: the construction loan (Facility 2) has been fully funded as of September 27<sup>th</sup>, the permanent loan (Facility 3) will commence on September 30<sup>th</sup>, and the interest rate swap (Facility 4) will also begin on September 30<sup>th</sup>.

At this time it is necessary to amend the Commitment Letter to reflect three changes:

- 1. To change the dollar value of SUB financing. Initially the SFSS had anticipated that up to \$44.3 million would need to be financed. Changes in project timing and cost have reduced this amount to \$36.2 million.
- 2. To remove the requirement that the permanent loan (Facility 3) be funded only upon receipt of a report indicating that final completion of the project had been achieved. The bank is now comfortable funding the permanent loan prior to final completion of the project.
- 3. The bank requires that confirmation continue to be provided on a monthly basis that all subtrades have been paid by the general contractor for their work on the project. This is done by providing a statutory declaration to the bank, a process which has been in place throughout financing and will now continue until total project completion.

# Key Considerations

1. These changes have no negative impact on the SFSS.

## **Executive Summary**

This paper will propose a much needed workshop program that will help student learn new skills and gain experience working with different computer software's. Even though SFU provide free access to online learning platforms such as Lynda.com and also computer resources that are available in the library. I still feel that there is a need to have an in person workshop that will provide deep understanding. The reason for this being that students do not have high motivation and completion rate online, also many students feel overwhelm by the information being provided online. This proposal will outline all the details of the program and the intension regarding the workshop.

## **Appropriateness to Mission**

## Description, scope, and purpose of the program

The proposed program hopes to enable SFU student to attain computer and other business skills that are highly in demand in the job market. Also, it hopes to especially help those students who are not part of or related to computer science background, gain knowledge and develop interest in computer field.

The program will be based on 8 weekly workshops, focusing on one core skill each semester, for example UI/UX design workshop. The workshop will have 1 hour 30 minute of run time, and will be divided into 3 main parts –

- 1. Theory: Which will cover basic theory and knowledge related to the skill and all the best practices.
- 2. Practical: This part will apply the theory learned in the first part of the workshop, and let instructor demonstrate their knowledge.

3. Practice: In this part students will be free to gain experience and get familiar with the environment.

The workshop will only help students gain basic knowledge of the software and equip them with proper tools, which later they can use to gain advance knowledge on their own, through any means they would prepare.

The need for this initiative is to engage our student and broaden their interest in other fields, while equipping them with proper tool and skills which are in high demand in the job market. So that they can have better edge after they graduate.

### Need

Ever growing market and technology develops the new job opportunities, yet at the same time eliminates many old jobs through the process of automation. As we are moving towards more advance society and overcoming our weakness with the help of technology. A question arises on our education system especially our Arts department, which is preparing students for the jobs and market which might not even exist till the time student graduate. This have made me realize that we need to train our student provide them with such skills that will help them in current job market.

According Canadian Information and Communication Technologies (ICT) profile of 2018. There has been an increase of 3.9% in the technology related sector, bringing \$193 Billion in revenue, also the software and computer services hold 66.4% of ICT market.





To an extend we can all agree that technology and computer related skill hold more value in the current state of the market and will only increase as we progress towards the more advance future. SFU do provide student with the free access to Lynda.com and students are free to learn any course they like. So how this will in person workshop will benefit students? Many students take distance education for variety of reasons such as travel issues, course availability, and timing issues (Summers, J. J., Waigandt, A., & Whittaker, T. A. 2005). And many studies suggest that there is not a significant difference in performance between student who study online and those who take in person courses (Summers, J.et al. 2005). But there is a significant difference in the level of motivation, most students who take online courses do not complete their course, but students who take in person classes have high completion rate (McFarland, D., & Hamilton, D. 2005). Also, students who are enrolled in traditional classes tend to report higher satisfaction course understanding (McFarland, D., & Hamilton, D. 2005). It is important to hold this workshop in person, due to the limited knowledge of students toward the course. Many students might not have high level of understanding of the course that is being taught to them and will required extra attention from the instructor. Also, as someone starting from the beginning will have more difficulties understanding software and tools online, rather than in person.

## **Academic Integrity**

### **Program structure and administration**

The instructor for the workshop will be appointed on the basis of their relevant experience related to the skill which is being taught in the particular semester. Instructor can be a near graduate, master or even a non-SFU personal who is willing to volunteer their time for teaching. Instructor job will be will be advertised as a volunteer position with an appropriate amount of honorarium upon completion of the commitment.

The program will be directed by myself (Samad Raza) for the purpose of following through the vision and mission of the program and director will not be receiving any kind of honorarium or pay. But, SFSS will appoint one board member to the workshop as the program coordinator and advisor. Who will be responsible of communication between the administration of the program and SFSS, also the personal will make sure that the program will be following all the code and conduct of both SFU and SFSS.

Other stuff, such as Marketing team, instructor assistant, administrator assistant, will be hired on the need basis and will be advertised as volunteer position without any honorarium.

The goal of this program is to build basic understanding of the software/skills that are highly in demand or are anticipated to help students in promoting their interests. The program hopes to improve student's chances of finding jobs in the field that they have high interest in, or help them do better in the similar course that they are taking at SFU.

The program will be offered without any fees and will be funded by SFSS. There will be a small amount situated for the purpose of the registration for the workshop, but the amount will be returned to the student upon their completion of program and 90% of their attendance.

## **Curriculum overview**

There will be no prior requirement for the registration into the program, and it will be open to all the student at SFU.

The workshop will have 1 hour 30 minute of run time, and will be divided into 3 main parts -

- 1. Theory: Which will cover basic theory and knowledge related to the skill and all the best practices.
- 2. Practical: This part will apply the theory learned in the first part of the workshop, and let instructor demonstrate their knowledge.
- 3. Practice: In this part students will be free to gain experience and get familiar with the environment.

The detail Curriculum will be prepared upon the voting result on this proposal and with the help of appointed instructor.

## **Coordination with Other Programs**

# With related programs at other institutions

The program will be open on the idea of collaboration with other institutes on the basis of need and requirement.

### With other departments/units on campus

All the departments at SFU will be welcomed to be part of the workshop and have their input in building curriculum and collaborating to make it a bigger scale workshop.

## With outside agencies, corporations, etc.

There are many Tech companies out there that can be looked as a potential sponsor and facilitator for the program. The program will be open to the idea of acquiring third party sponsor if needed.

## Periodic Assesment

At the end of the workshop students will be asked to fill out a standardize survey for the purpose of evaluation and feedback. Upon accruing the survey results a committee will be setup to analyze the survey results and make appropriate changes for the purpose of program improvement.

# **Resources Sufficiency**

For the purpose of the pilot program. I would like to suggest the use of 2<sup>nd</sup> floor lab at the WAC Bennett Library. Which is equipped with sufficient seating, computers and software. This will help us develop the understanding on regulation of resources and need of expansion.

Talks the Simon Fraser Student Society and Graduate Student Society were having with SFU Administration about the budget creation and consultation have broken down. Aligning the SFU budget creation and consultation process and our efforts to prioritizing student fees affordability during the budget creation process, have stalled.

Regrettably SFU did not provide the Student Societies with the extensive information that we requested and that would allow our organizations to perform sound analysis and provide informed advice.

Further, at a recent meeting, SFU took a hardline stance offering only two options which, without further information and more details about the discretionary budget, makes it impossible for us to ascertain their validity.

SFU is proposing the following two options for tuition fees increases:

- option A 2% domestic / 4% international split and;
- option B 2% domestic / 8% incoming undergrad split,

We believe that the latter is a red herring. As a result, we will be recommending to our respective Boards to support a Tuition Freeze.

We are pleased that many individuals from SFU Admin have recognized the importance of student input and we plan to work on formalizing the process over the next year through the Joint Operations Group (JOG) meetings. It is important for SFU Admin to also recognize and agree that the current consultation process is flawed and there is a need for significant changes that lead to genuine student consultation based in openness and transparency.

In the immediate term, if SFU was to freeze tuition from its current 2% / 4% split, it would forgo \$7 million dollars from their projected revenue. Additionally, every 1% of increase in International tuition, adds \$1.3 million to the University's coffers. SFU's overall operating budget is approximately \$500 million. We believe that economies can be found within that budget rather than increases in revenues from students.

We believe that many of the projects SFU has currently planned, capital or otherwise, could be delayed or held off, this would allow for SFSS/GSS to assist SFU in its own advocacy to attenuate the chronic underfunding of post-secondary education by the government. This requires further planning and execution with longer timelines.

Although multiple surveys around students' interests have demonstrated growing concerns about affordability, SFU continues to fail in its actions, choosing instead to forgo pro-activity and fuel an antagonistic stance.

In conclusion, SFU's budget consultation and process should unequivocally be centered on students and their priorities: students voices must be heard. Again. Louder.
