BRIEFING NOTE

STADIUM PROJECT: REVIEW AND APPROVAL OF DESIGN

ISSUE

The SFSS Board of Directors approved the Stadium Project Contribution Agreement in March, 2017. Within the agreement, SFU is required to obtain the SFSS's approval of the plans and specifications for the stadium. The stadium has undergone a redesign since March and SFU is now seeking SFSS approval.

BACKGROUND

The Stadium Project Contribution Agreement requires that the stadium include, at a minimum:

- 1,800 seats, where each seat is approximately 20 inches wide and include a backrest,
- A full roof,
- A press box, and
- Ancillary work necessary to support the construction of the stadium.

SFU is also required to create a work plan for the stadium project including a description of tasks, milestones, and deliverables (Appendix 2), and determine a budget for the project (Appendix 3).

CURRENT STATUS

The stadium has undergone a complete redesign over the summer (Appendix 1). The new design meets the requirements set out above <u>except</u> that the roof does not cover all seats. Of the 1,823 total seats, 1,152 (63%) are covered and 671 (37%) are not covered.

SFU has provided a memorandum (Appendix 4) listing each of the four requirements, whether each requirement has been met, and further information regarding seating, costing, and materials. The memo falsely indicates that all four requirements have been met including the requirement for "a full roof".

Key Considerations

The redesign of the stadium has resulted in the following changes to the project since the previous iteration of the design:

1. Project cost is now estimated to be \$14.2 million, down from \$16.7 million. (The SFSS's contribution remains capped at \$10 million.)

- 2. Stadium seating is now centred on the field rather than spanning from the middle of the field to the east end.
- 3. The roof covers 63% of seats rather than 100% of seats.
- 4. The roof is supported from the north end and no longer requires columns within the seating area.

RECOMMENDATION

That the Board of Directors receive a presentation from the architects and SFU representatives and move to approve or reject the plans as presented.

NEXT STEPS

- 1. Pending the approval of the SFSS Board of Directors, the stadium design will be presented to the SFU President and Vice Presidents for review.
- 2. SFU will submit a Preliminary Plan Approval (PPA) to the City of Burnaby. An approved PPA is required before submitting an application for a Building Permit.
- 3. Construction Documents will be created by the architects and other consultants.

SCHEDULE

Perkins+Will understands that SFU and SFSS have agreed to a project schedule based on two dates:

- Commencement of Construction 18 months after the signing of the project agreement in March 2017 (Construction commencement September 2018)
- Substantial Completion of Construction 36 months after the signing of the project agreement in March 2017 (Substantial Completion March 2020)

This timeframe requires a fast track approach to the project design and documentation. Perkins+Will and our consultant team will do everything in our control to complete our work

to allow SFU to meet these milestone dates, and our attached workplan outlines our approach through the completion of construction documents. However, our preliminary discussions with the City of Burnaby have indicated that a building permit process currently takes approximately two years. Based on direction from SFU, we have assumed a one year approvals timeline in our schedule. These factors, along with the contractor's ability to meet the construction completion dates, are beyond Perkins+Will's control, and may affect the ability to meet these target dates.

In preparation for the Stadium Project Presentation to the Simon Fraser Student Society Board of Directors on Friday, September 29, 2017, please find below further information in response to your questions regarding the project.

Stadium Project Contribution Agreement | Listing of requirements

As noted in Section 3.1(a) of the Stadium Project Contribution Agreement, the university is required to work with the SFSS and obtain the SFSS' approval of "the scope of the design of the Stadium Project". The following outlines the requirements as per the agreement, indicates that all requirements have been met, and adds comments where appropriate.

Seating

With regards to the difference seating types, the thought was to provide a number of different viewing experiences: the folding seats under the canopy, the fixed seats facing the track starting and finishing lines (which might have a more raucous atmosphere, like the Southsiders at Whitecaps games), the informal seating integrated into the berm (or 'grassy knoll') to the east, and the terrace to the west. The areas are all differentiated and, in time, the thought is that each area may take on its own personality and provide a vast range of experiences for fans and users alike.

Costing and Materials

The estimated project cost has gone down \$2.5 million, from \$16.7 million provided approximately a year ago (BTA Cost Consultants) to \$14.2 million today (Jim Bush & Associates).

The cost difference is mainly due to a lower estimated allowance for construction management, contingency, and soft costs (consultant fees, equipment, project admin, permits, tax) and not due to a lesser quality of "materials, finishing and structural components".

The materials are the same or better than those used in previous designs. Materials have been selected for their durability and ease of maintenance, to ensure that the facility retains its aesthetic appeal and is able to be kept in good working order. As shown at the Open House (and to be included in the presentation on Friday), a listing of the material used includes cross laminated timber panels for the canopy; porcelain tile panels and tinted glass for the press box; painted steel columns as part of the structure as well as metal railings, cast-in-place concrete and pre-cast concrete.

The estimated value for the canopy structure was very similar in both estimates (\$2.7 million compared to \$2.63 million). The cost has actually gone up in the most recent estimate for aspects of the stadium that are of most importance to the user - including seating, finishes and spaces.

Executive Summary

Preface

The Simon Fraser Student Society (SFSS) represents 29, 994 undergraduate students attending Simon Fraser University (SFU or the "University") across three main campuses in Burnaby, Surrey, and Vancouver. We would like to thank the Government of British Columbia for the following investments:

- \$1.98 billion for advanced education
- \$2.6 billion in capital spending over three years by postsecondary institutions across the province in Budget 2017 (pg. 32)
- \$24.5 billion in support of infrastructure investments for hospitals, post-secondary, transit and roads over the course of the fiscal year (pg.31)
- The U-Pass BC program
- Maintaining the Tuition Limit Policy and limiting increases for tuition and mandatory fees at 2% per year.
- \$90-million investment for Energy Systems and Environmental Engineering Program by the federal and provincial governments

Now that the Provincial Government has realized a \$2.8 billion surplus for this fiscal year (2017/18), we would like to recommend that the committee take the following recommendations into consideration:

Recommendation 1

The creation of needs-based grants program for low-income students attending a BC post-secondary institution.



Background:



94.0% approval rate at Spring 2016 U-Pass referendum

Student Loan program calculated student living allowance for public transportation in BC was \$105

U-Pass provides a critical service to post-secondary students in the Metro Vancouver region and it is vital that the provincial government commits to continuing this program.

Recommendation 3

Provide targeted funding to post-secondary institutions for mental health support services for students.

Background:

Simon Fraser Student Society Advocacy Survey (Simon Fraser Student Society, 2017):

• Over 61% of 492 students surveyed consider mental health very important.

StudentCare Survey (Simon Fraser Student Society, 2017):

- 76.0% say mental health is very important
- 71.4% placing mental health at the same level of importance as their physical health
 - 26.2% ranking their mental health above their physical health.
- 97.2% of respondents either agree or strongly agree that our society needs to reduce prejudice and discrimination against people experiencing a mental illness.
- 51.2% have personally experienced a mental illness
 - 52.4% have been treated negatively or unfairly in the past because of a mental health problem.
- 194% increase in claims for Psychology and Counselling services.

The Simon Fraser Student Society (SFSS) represents 22, 978 (Simon Fraser University, 2017) undergraduate students attending Simon Fraser University (SFU or the "University") across three main campuses in Burnaby, Surrey, and Vancouver. We would like to begin by thanking the Government of British Columbia for the following investments:

- \$1.98 billion for advanced education
- \$2.6 billion in capital spending over three years by postsecondary institutions across the province in Budget 2017 (pg. 32)
- \$24.5 billion in support of infrastructure investments for hospitals, post-secondary, transit and roads over the course of the 2016/17 fiscal year (pg.31)
- The U-Pass BC program
- Maintaining the Tuition Limit Policy and limiting increases for tuition and mandatory fees at 2% per year.
- \$90-million investment for Energy Systems and Environmental Engineering Program by the federal and provincial governments

The economic value of investments made into post-secondary education cannot be discounted. Retirements and economic growth are predicted to open up one million job openings in BC by 2024 (Ministry of Advanced Education, 2017). As noted in the British Columbia 2025 Labour Market Outlook more than three quarters of the job openings projected for 2025 will require some post-secondary education, with 36% requiring a bachelor's degree(figure 1)(WorkBC, 2016).





FIGURE 6: Ten-Year Total Job Openings by Education Requirements

Additionally, the 2017 BC student outcomes report found that the majority of postsecondary graduates were successful in obtaining employment post studies with 83% employed in the labour force, and only 8.6% being unemployed in the labour force (BC Student Outcomes, 2016). Investments into education further individual intellect and produces a workforce who are equipped with the appropriate training required by employers. A lower unemployment also reiterates the importance of investing into post-secondary education to ensure that BC has skilled workers. Skilled workers are then able to capitalize on the predicted economic opportunity of one million jobs by 2024 and ensures that labour market needs are met to fill these jobs.




Figure 2 -Number graduates surveyed in 2016 with baccalaureate accreditation in the labour force

Introduction:

During last year's consultations submissions on post-secondary education constituted a large portion of the public input on Budget 2017. Last year's consultations also resulted in the committee including a number of recommendations put forward by the Simon Fraser Student Society (SFSS) and other student unions. These recommendations were to:

- 20. Develop a solution to enable post-secondary institutions to finance self-supported capital projects, including student residences and housing.
- 21. Increase operating grants to post-secondary institutions to address unfunded cost pressures and move to multi-year allotments for operating grants and deferred maintenance grants to help these institutions with their financial planning.
- 22. Increase funding for programs to address areas with identified skills gaps in the workforce, such as physical therapy, engineering and technology and applied research. Tuition and Financial Assistance

23. Establish a needs-based student grant program that addresses student needs and provides incentives for completion and conduct a review of the current B.C. student loan eligibility requirements and interest charged on B.C. student loans.

While the insufficiencies in funding for deferred maintenance at SFU Burnaby campus is of concern to us, we limit our recommendations in this report to our three most student-centric suggestions. This is an opportune moment for the Provincial Government to take action given the \$2.8 billion surplus for this fiscal year (2017/18). Our recommendations are as follows:

- 1. The creation of needs-based grants program for low-income students attending a BC post-secondary institution.
- 2. Long term funding for the U-Pass BC program
- **3.** Provide targeted funding to post-secondary institutions for mental health support services for students.

Recommendation 1:

The creation of need-based financial aid program for low-income students attending a BC post-secondary institution.

Background:

BC is the only province in Canada without a needs based grants program. Need-based financial aid is granted to students based on their financial need. Since a need- based program does not exist in BC, many students from lower-income families need to take out student loans to fund their education. Students who take out loans to pay for their education often start out in the labour market with huge amounts of debt. The debt burdens students entering the workforce with an initial economic disadvantage. Student loan debt limits the student's purchasing power and capacity to engage in the economy for years after graduation. This is especially the case in the Vancouver housing market. Students who take out loans for education purposes are statistically likely to continue to make less money over their lives in comparison to students who do not need to take loans. The interest rates on student loans, essentially forces students to pays more for their education for a longer period of time than a student who did not need to take out a student loan.

Rationale:

The Government of Ontario made changes to its student financial aid system that will make average college and university tuition free for low-income students. In Ontario, students who are low income holders received non-repayable needs-based grants that enabled them to access postsecondary education. The Government of Ontario is eliminating barriers for low-income students to access education from a post-secondary institution. By providing the fundamental right to education to students who cannot afford to pay for post-secondary education, the government of Ontario has opened an opportunity for their provinces' economy to grow and at the same time has allowed students to gain skills necessary for the labour market. Likewise, the province of New Brunswick introduced the new Tuition Access Bursary to provide upfront financial assistance to low income students. Meanwhile, B.C. remains an outlier - the only province without a needs-based grants program where students receive the lowest proportion of non-repayable student assistance in the country. We are creating the most indebted generation in history – a socioeconomic development that will have deep and long-lasting consequences for British Columbians and the longterm health of our economy. If the B.C. government wants to lay the foundations for a growing, robust, and diverse economy, it should take the lead from the Government of Ontario (and all other Canadian provinces) and create a provincial system of upfront, needs-based grants.



Recommendation 2:

Demonstrate that funding for U-Pass BC has been allocated beyond April 2018 as a longterm priority for increasing student affordability. End cyclical contract expiry and develop a long-term, standardized and affordable U-Pass BC program indexed to inflation.

Background:

Since 2010, the government of BC, in partnership with Translink, student associations and public post-secondary institutions has been offering a universal transit pass to post-secondary students in Metro Vancouver. This universal pass allows them access to public transportation across all three zones of travel. Six years later, U-Pass BC is undoubtedly considered an essential service by post-secondary students who have shown their strong support for the program by consistently voting overwhelmingly in favour of continuing the U-Pass program, even though rates have increased year after year since its initial adoption. The most recent U-Pass referendum held at SFU in Spring 2016 received a 94.0% approval rate amongst undergraduate students (SFSS Independent Electoral Commission, 2016).


Rationale:

The U-Pass is used by tens of thousands of students at ten institutions in Metro Vancouver (Translink, 2016) and has been a successful program in increasing affordability for students, reinforcing transit culture and reducing the frequency of driving to campus. Transit usage increased significantly to the SFU campuses after the introduction of the U-Pass. It is reported that 88% of SFU undergraduates regularly use public transit to commute to the university, which is 31% higher than the national average (Simon Fraser University, 2015, B).

With the cost of living continually on the rise in the Lower Mainland, students face affordability issues in all aspects of their lives. A student who uses the U-Pass, currently priced at \$41.00 per month saves over \$1500 on public transit every year in comparison to a full-priced three-zone pass, priced at \$172 per month (Translink, 2017, B). Even students who only require a one-zone transit pass for the year benefit from the U-Pass, saving over \$600 compared to what they would pay without the U-Pass. These students also benefit from increased access to transit across the region at a price which is affordable to them.

Students must be able to rely on the long-term existence of the U-Pass in order to effectively budget for the cost of their education. In 2016-17 the student loan program's calculated student

living allowance for public transportation in BC was \$105 per year (Government of Canada, 2017). While this allowance would be just enough for a student to purchase a one-zone transit pass, at a cost of \$93, it would certainly not allow for students to purchase either a 2- or 3-zone passes, which cost \$126 and \$172 respectively (Translink, 2017, B). With SFU having 3 major campuses located across multiple municipalities, many students require the use of a 2-zone pass to attend classes on a day to day basis. Additionally, housing costs skyrocketing in Metro Vancouver and students being forced to move further away from campus in order to find affordable housing options.



In July 2015, the Government advised that funding had been made available to extend support to the U-Pass program BC for an additional two years. Subsequently, a contract was signed ensuring that the U-Pass program would continue until April 2018. U-Pass BC provides a critical service to post-secondary students in the Metro Vancouver region and it is vital that the provincial government commits to continuing this program by ending cyclical contract expiry and develop a long-term, standardized and affordable U-Pass BC program indexed to inflation.

Recommendation 3:

Provide targeted funding to post-secondary institutions for mental health support services for students.

Student mental health and wellbeing is fundamental to academic success and professional development. The BC government spends about \$1.5 billion per year to fund mental health and substance use programs and services, and has planned to invest \$5 million over three years to support the development of mental health initiatives for the post-secondary systems. However, details of the 3 year \$5 million investments are not disclosed. The SFSS recommends to continue investing in mental health initiatives and advocate for mental health issues. Furthermore, it is imperative to recognize that the average age of a SFU student is 21 years old and almost 70 per cent of serious mental health issues emerge before the age of 25, meaning that post-secondary students are at the core age of dealing with mental health issues (Lake, 2017).

According to the SFSS Advocacy Survey over 61% of 492 students surveyed consider mental health very important. Furthermore, the SFSS tasked our healthcare providers to survey student specifically about the stigmatization of mental illness in the student community. 455 surveys were completed and over three quarters of respondents (76.0%) say that the topic of mental health is very important to them, with 71.4% placing mental health at the same level of importance as their physical health and 26.2% ranking their mental health above their physical health. 97.2% of respondents either agree or strongly agree that our society needs to reduce prejudice and discrimination against people experiencing a mental illness. Of the 51.2% of surveyed students who have personally experienced a mental illness, more than half of them (52.4%) have been treated negatively or unfairly in the past because of a mental health problem (33.9% in the past year and 18.5% more than a year ago). 74.7% of surveyed students have a family member or close friend who has experienced a mental illness (Simon Fraser Student Society, 2017).

Furthermore, we have seen a 194% increase in claims for Psychology and Counselling services. Students have specifically commented that there is a lack of

advocacy for mental health disabilities. A lack of education for professors about the specific challenges faced by students with anxiety, depression, neuroatypicality, and other mental health problems. Students urge that students with suicidal ideation on campus need more support and these cases should be taken seriously (Simon Fraser Student Society, 2017). The SFSS encourages the government to strategically allocate funds across post-secondary campuses and highly encourages government to openly destigmatize mental illness by creating a mandate for every university to create a comprehensive multi-year mental health strategy (Simon Fraser Student Society, 2017).

Broadest Policy Provision:

In order to protect the Board from the sudden loss of the services of the Chief Executive Officer, the Chief Executive Officer shall not permit that there be fewer than 1 employee who is sufficiently familiar with Board and Chief Executive Officer issues and procedures as to take over the obligations of the Chief Executive Officer with reasonable proficiency as an interim successor.

CEO Interpretation:

I interpret "sudden loss of CEO services" to mean three weeks, or less, notice that the existing CEO is unable to perform his duties. I interpret "sufficiently familiar with Board and CEO issues" to mean that the selected individuals will be familiar with the specific projects that are being undertaken by the CEO.

Data:

SFSS has a small leadership complement and they are attached to specific services or initiatives. In our current staffing structure, there is no single position that can easily be tapped to be the "executive successor". As a result, the CEO has created a number of opportunities for staff and management to play leading roles (with CEO support) in a number of key initiatives, including the following:

Food Court Tenant Management:	Build SFU General Manager
Food and Beverage Transition:	Build SFU General Manager Administrative Supervisor
Office Reorganization:	Build SFU General Manager Administrative Supervisor

Annual General Meeting:	Administrative Supervisor
Board Orientation/Development:	Campaigns, Policy, Research Coordinator
Standard Operating Procedures:	Campaigns, Policy, Research Coordinator
SFSS Staff Appreciation:	Administrative Supervisor
Granting Procedures:	Student Union Organizer GO Coordinators
Website Redevelopment:	Communications Coordinator
Qualitative Service Feedback:	Communications Coordinator Campaigns, Policy, Research Coordinator

This shared approach not only ensures that we have staff and management attached to key initiatives, it also provides our employees with important opportunities to develop their skills and knowledge.

The CEO, Build SFU General Manager and the Administrative Supervisor also have regular monthly meetings where we review a variety of management and operational issues, to ensure that our priorities are clear and next steps in key areas are understood and assigned as required.

<u>Status:</u> I report compliance.

Analysis:

SFSS is a small organization. In our current structure, we have one senior manager (the CEO), a project-based manager (the Build SFU GM) and one Administrative Supervisor. All other employees are members of the bargaining unit.

SFSS has been undergoing a great deal of change in the last two years. The Board has adopted new governance policies and has reconfirmed the importance of engaging with students to determine how we can best represent their interests and aspirations. We have also:

- ✓ secured the financing and other agreements required to build the new Student Union Building (the building is scheduled to be completed by Fall 2018);
- ✓ Closed our food and beverage operations and negotiated a related space transfer agreement with SFU;
- ✓ Developed (and began to implement) our first strategic plan.

As we look forward, there are a number of significant strategic and operational issues and opportunities that we need to address in the next few years, including:

- ✓ Transitioning from our current location to the SUB;
- ✓ Developing annual operating plans for each core area within SFSS;
- ✓ Completing standard operating procedures for operational tasks;
- \checkmark Completing and implementing a transition plan to move us to the SUB;
- ✓ Developing and implementing a "Request for Proposals" process to deliver our student health and dental plan;
- \checkmark Developing a new engagement program for the SUB;
- \checkmark Continuing to implement the strategic plan and the Board work plan(s).

In short, there are a great deal of strategic and operational priorities require our focus in the coming years.

Recommendation(s):

It is recommended that we hire an Operations Manager to focus on member-facing service delivery, acting as a liaison with SFU Facilities to ensure that building management issues are identified and addressed and to assist the CEO with other strategic and operational items that need management support. Having an Operations Manager will add a level of formal management support that will ensure adequate coverage during the CEO's absence, while providing ongoing direction and support in key parts of our organization.

Summary of main points and responses to some common objections about the proposal to find a new name

There are many uses of the term Clan in Canada, and these are worthwhile and not intrinsically racist. Even in the US, the problem is not that using the term is intrinsically racist. It is not like the Washington Redskins, for instance, which is an explicit pejorative. People from various Clans are not racist for being from a Clan, nor should Canadians have to alter what they mean by it. What is problematic is playing with the team name Clan *in the United States*. The fact that SFU petitioned to join an exclusively US collegiate sports association is important. It means that we chose to play against US teams, rather than Canadian teams, and that we made that choice, not the NCAA asking us to join them. The issue here is not that Clans are racist, or that any mention of the term Clan is problematic. Any of Scottish descent can happily continue being of Scottish descent, and can proudly speak about their history as they want. The big difference is that none of them are a sports team in the NCAA. Fortunately, no actual Scottish history is entrusted to the athletics team; our choosing a new name cannot erase that history.

Choosing a new name is more like a new chapter in a book of SFU. But there is already a new chapter happening, the one with SFU in the NCAA and especially the one where we finally have a new stadium and chance to get students involved in our athletic endeavors. Our student athletes deserve the chance to be taken seriously by their opponents when they play. Our students here deserve to be represented by our sports teams in a way that is **unambiguously** awesome. We need to be able to chant our own team name without concern.

What's different now? While SFU has played in the NIAI before, the NCAA is a much more extensive and dominant sports association for collegiate athletics. This means that there is something different now compared to past generations of students. And the US is struggling with its past in ways that Canada does not culturally share. The US has a real history of slavery that, regardless of the problematic history of colonialism in Canada, is genuinely different. The US imported millions of human beings to treat them as property. In the Jim Crow era, they brutally suppressed the descendants of slaves, their very own citizens. This only improved somewhat through the extensive struggles in the Civil Rights era of the 1960's. Recently, major progress like the Voting Rights Act and laws protecting black students from segregation in education have been repealed or overturned, and the result has been an abrupt return to voter suppression and segregation. The people who bear the brunt of playing a team named the Clan are not those doing the suppression; it is the student athletes in the US, including the Black student athletes there, who have to deal with all this in the rest of their lives. We then make them deal with it a little bit more, by having to ignore what that word sounds like to them, when they play against us.

While it is important to note that many of our **own** student athletes have reservations about this name, or just want something new, this is not just for them. It is for our competitors as well. We can **choose** to treat them respectfully. No one can force us to do that, if we want to ignore our place in the broader fabric of North America. But now that we asked to join the US sporting association, to demand that **they** acknowledge **our** understanding of the term, without **us** respecting **their** understanding of the term, just is a way of being disrespectful to them. We can choose to do that, but we can also just choose to not do that. We can choose to be awesome, and recognize that as the world changes, this is the new way of being awesome abroad.

I don't think Canadians always understand how deeply visceral the reaction is that USians have to

the name Clan/Klan. There is a *century long* history of that as the name for a genuinely horrible terrorist organization, one that is still incredibly active and terrorizing people. This is a hate group that the current US President's own father was a member of. They don't even hide their faces anymore. The Klan is just the US' homegrown Neo-Nazis. It is a sad fact but not one we can in good conscience ignore. It is unfair to Black student athletes in the US to ask them to play against a team named the Clan. As academics, I think we can recognize those students and their legitimate needs as worth acknowledging. To treat *them* respectfully means not asking them to pretend like the word Clan/Klan means something different to them than it actually does. And what it actually means is a terrorist group that has the explicit goal of eliminating them.

Regardless of its Canadian meaning, in the US, no student athlete will be able to play against our team and have anything other than this deeply visceral disgust reaction. This is not to label The Clan as inherently racist. It is just an objective fact about the US and its social situation.

That 'klan' and 'clan' are homonyms: These are not actually homonyms. To be a homonym, they must have different meanings with the same sound. 'Two' and 'too' are homonyms. 'Klan' and 'clan' are the same word, derived from the same source, and transliterated into contemporary English slightly differently. The Klan, as in the KKK, is drawing on exactly the same word, from the same Scottish heritage and understanding of familial/political factions as does the Clan for SFU. Both Clan and Klan are named after the very same thing, which means that by definition, they are not homonyms. They are different spellings of the same word, and different groups named after the same thing, but this is not what a homonym is.

To the idea that we should educate about Scottish history instead of changing the name: Everyone in the US and Canada know that we don't mean that Klan. The issue is not that people in the US will mistake us for the actual white supremacist organization. Education about Scottish history is entirely besides the point, and somewhat condescending to those US students, especially visible minorities. They don't need to be told by us, "that's not what we mean!" because they already know that. They know where that word comes from. Yet they will still feel that kick to the gut when our team is announced. Telling them more about Scottish history comes across as tone-deaf, because their response, rightly, may be, "Let me tell you about some history of the Klan in the US, and how many members of the Klan are on police forces, are judges, are prosecutors. Let me tell you about ongoing police brutality against black people in this country. Let me tell you about my cousin/brother/uncle/grandfather/aunt/self..."

They should not have to pretend like that word has no visceral meaning for them, in order to go to college via the only avenue available to them. This is what we are doing to those student athletes. It is in recognition of them that I keep pushing this point. We are just making it a bit more humiliating for them. We can just, not do that.

It's worth pointing out that words are not just what we decide on our own that they mean, we can't just mean what we want by sheer force of intention. As someone in linguistics pointed out, words have meaning in communicative contexts with participants, such that we cannot assert our own meaning for a word in a context where it already has a meaning. In the context of US collegiate sports like the NCAA, the term Clan already has meaning. For us to go into the US and then demand that they use our meaning, even though they already have that word with its own meaning (and a pretty horrible one at that), is an rather unfair imposition on the US student athletes. They did not ask us to join, we asked to join them. That matters.

Further to this, others pointed out that actually, the Clan system in Scotland was not necessarily something to idealize or glorify without a clear-eyed view of what we are idealizing. Another person pointed out that sports team actually aren't a Clan in the relevant way, such that Clan pride does not mean SFU has to keep that name for its teams. And, multiple people pointed out that the history of Scottish colonization in British Columbia is not itself something to be proud of, especially in the middle of the process of implementing Reconciliation reforms. We don't want to romanticize Scottish heritage by falsifying history.

And, it turns out that even to many Scottish people, our usage of the term Clan comes across as really awkward and strange. It is a term that comes before a family name, like Clan Fraser or Clan MacEwan. The say it as, The Clan, sounds stilted.

FWIW, I think we should be the Tartans. Or, the Highlanders, also a great name for a Scottish school on top of a (little) mountain. Since we do have some real Scottish history and ongoing culture in the form of a world class Pipe band, we could also be the Pipers, and find ways to incorporate the Pipe Band or other drum lines into the sporting events. Student organizations could actually have spirit rallies and pep events with either of those themes, building community of the sort that our students all wish for more of. Coming up with a new name can be a great thing for the school, a way to actually get people more involved in our sports activities, and a great campaign to kick off in the fall term.

In response to the claim that this is just giving in to US politics and letting current US political issues dictate what we do: American politics is not the issue. It is especially not an issue of contemporary American politics. I have been raising this issue since Obama's presidency. SFU has been a laughingstock in the US for decades (ask around with American colleagues, friends, or teammates, tell them your team name and see what they say).

It is in many ways a charming part of what one might call Canadian privilege, to not feel that gut kick when you hear the word Clan. It is fantastic for those who are from a country without that terrible history of slavery, Jim Crow laws, and continuous oppression of black citizens. But it is privilege to pretend like we get to mean whatever we want to mean, and that others in the US should just recognize or know what *we* mean even given what they have faced. That is not new to American politics. That is a century old issue.

Joining the NCAA meant we invited ourselves into a US college athletics house. In many parts of the US, no one takes their shoes off when they go inside a house. But it would be really rude to go over to someone's house where they expect you to take your shoes off, and walk all over the place with your muddy boots on, because "I don't take my shoes off where I live!". Surely your host could understand that, in the sense of knowing that it's true. But also as surely, it would be self-absorbed and rude. That is what it is like to go join the NCAA with the name of the Clan.

Consider what it would be like to be a twenty year old black athlete competing against a team named the Clan. I used to teach at the University of Pittsburgh, which had a substantial group of black athletes, many of whom were at the University only because they had an athletic scholarship, many of whom were there for the first time in their families. If you are raised in a black community in the US, you were taught, by your parents and your grandparents, what to do if you found out that a

boss, a coach, a friend's parent, or even a professor of yours turned out to be a member of the Klan. I had a student graphically describe what this was like, in terms of what you do when you accidentally see that hood in a drawer, and how to protect yourself. Now imagine that student has to play against a team named the Clan. He knows it isn't **that** Klan. But every time the announcer says our team's name, he gets a little jolt of anxiety. In the US, there is no way around that jolt, especially for minority students, and most especially now that the Klan is marching openly on a regular basis.

Individual Workshop Notes:

Lev Bukhman Keynote speaker:

The presentation was focused on indicating to us how we could translate our skills currently to both future initiatives as Board members and also after our term in office ends. According to Bukhman who is the founder of Student Care, psychoactive medications are becoming increasingly prescribed for students and are now the most common prescription amongst undergraduates. A possible explanation for this is because of isolated students not being sufficiently engaged in social interactions thereby enhancing risks of mental health problems.

Nonetheless, Bukhman asserts that student apathy does not exist. By saying students simply don't care and therefore do not get involved is an invalid justification. By doing so, it detracts from student society efforts to engage others. He then alludes to the fact that even those students that participate in society governance are often minimally involved, such as Councils. To enhance the involvement of Council, Bukhman suggested hiring a lawyer to chair a

meeting at least initially so that Councillors become acquainted with a strict, fast-pace, efficient setting.

Ultimately, when it comes to learning how to engage others properly, Bukhman states that it is important to make others feel a part of something bigger than just themselves individually. To do so, enthusiasm is essential as the key piece to successful engagement. He also recommended to achieve this using more traditional methods that are in-person rather than focusing on online presence.

Finally, Bukhman mentioned the importance of self-care and that doing engagement 'the right way' is exhausting. As such, we ought to take time out for ourselves and do things we enjoy whenever the opportunity arises.

Campus Sexual Violence: Responding to disclosures:

At this workshop presented by Ending Violence Association, definitions were laid out in the beginning. Sexual violence is a continuum of sexual harm both physical and mentally. Comparatively, sexual harassment is unwelcome sexual conduct whereas sexual assault is unlawful sexual conduct. Following these definitions, a video titled "Consent is like tea" was played. This video is used by SFU and these definitions are in-line with SFU's and our Women Centre's definitions.

We also went over myths as well such as that it doesn't happen to men, that women automatically consent to sexual violence when in a relationship, that no means yes, that the most common offenders are strangers, that some people 'ask' for it, and that police must always be involved.

According to research from Dr. Lisak, David, perpetrators are in fact non-strangers and most are repeat offenders who deliberately target vulnerable individuals. They extensively plan their assaults using drugs/alcohol to increase vulnerability and utilize minimal force to avoid detection(e.g. Not leave wounds on victim). Of note, 1/3 women are sexually assaulted, 66% female sexual assault survivors are under 24. Victims at universities are 25% females, 6% male, and 25% LGBTQ+. Additionally, over 50% of incidents occur in the presence of substances and during the first 8 weeks of classes. 60-70% of on campus assaults occur on residences and 95% of perpetrators in Canada are men.

Interestingly, what is seldom discussed is how trauma impacts the brain. The limbic system is responsible for fear and pleasure that is instinctual. The neocortex for learning and planning that is conscientious. The amygdala responds to danger. When danger such as an assault is experienced, the body releases epinephrine which stops all non-critical functions. The hippocampus, which usually files memories, stops and starts releasing cortisol instead. This is why it can be difficult for memory retention of the event in recalling it amongst victims. This can also result in a 'freeze' response that is instinctual. The person's body becomes rigid and still, unable to move. Concurrently, the person becomes unable to process thoughts because neocortex is also temporarily stopped. Everyone is impacted differently, but disclosures are nonetheless uncomfortable for most.

The function of the brain in traumatic incidents was discussed because the presenters really emphasized that as leaders we should be appproach victims of sexaul assualts in a trauma informed manner. This means that we should avoid all forms of contact and avoid speaking in a sympathetic way. We also need to understand the trauma may cause people to

become silent when discussing the incident. When a person who is disclosing becomes silent, we should never assume that nothing has happened. Instead we should realize trauma causes certain areas of the brain to shut down which may stop them from speaking or remembering exact details.

Disclosures are different from reports. Reports are official complaints to authorities such as the university administration or police and generally involves the initiation of an investigative process to find fault. Disclosures are simply telling the incident to someone informally. Disclosures may be to receive medical care such as by telling a counsellor. In BC, third party reporting by sexual assault service is possible. This means that victims wanting to alert authorities but do not want to be involved in an investigation can get someone else to tell the police on their behalf. The best practice then, is non-mandatory reporting so survivors are empowered to decide. Currently, only 5% of sexual assaults are reported to police and so the best steps are to learn how to recognize, avoid, and support.

In responding to a disclosure, never say "it'll be okay" or somehow trying to indicate you know how they feel. All experiences are different so it is impossible to know the experience and promising everything will be fine is a false promise given that this may not be true. Instead, be honest and thank them for telling you. Listen, believe, and empower the person as much as possible such as by using their language (e.g. if they use slang terms for the incident then use it). Finally, some people are tempted to provide hugs when someone is violated, but instead, ask, as they may not be comfortable doing so. Ask if hugging is okay and also ask what they need to be explicitly clear on how you can support them.

Creating Accessible Education: Open Educational Resources

At this workshop, Rajiv Jhangiani, a member of the BC Open Campus team presented on what OERs are and their importance in education. Rajiv starts with a guote from the universal declaration of Human Rights that "higher education shall be accessible to all." Rajiv transitions into the realm of cost, showing that textbooks can be up to 25% of the educational costs for students in their first year; this cost may cause some individuals to work to pay for these textbooks, decreasing time for their study, which is the exact opposite purpose of purchasing the textbook in the first place. A couple of slides focus on the harsh reality, that student loans leave individuals in severe debt, preventing some individuals from taking further education, just due to financial reasons. Furthermore, he brought the room's attention to how post-secondary students across the country are using food banks much greater than before. Additionally, textbooks in the US have been inflated by 207% from 1996-2016 according to CPI: Selected Consumer Goods and Services. Rajiv shifted the topic and essentially discussed how new versions of textbooks aren't always better, quoting a University of Minnesota student saying: "I figured French hadn't changed that much," who did well in their course using an international edition of the book. To cope with the cost of textbooks, he mentioned how students are resorting to downloading their books illegally when they get a chance. He shared a study showing when traditional textbooks are required for students, a lot of students refrain from purchasing the book and earn a poor grade as a result. Students may take fewer courses to cope with the costs, don't register for specific courses that have expensive textbooks, or even drop a course. He mentioned how publishers have realized that students don't buy the expensive textbooks that are bound due to the steep initial costs; as a result, they attempt to create more online copies,

which may seem good at first, but these are a lease on the book for the most part. After a set period of time, individuals lose access to their books and won't even be able to sell it to make up some of your initial cost of purchase, effectively making these books "a wolf in sheep's clothing." Rajiv then introduces the open textbooks and the #textbookbrokebc campaign. He focuses on how open educational resources abide by the 5 R's:

- Revise & Remix: this is the ability edit the resource
- Retain: won't lose access to it
- Redistribute: ability to share with other, legally!
- And they also must be Reusable

He also mentioned that these aren't applicable to only books but to numerous things, such as pictures and videos (e.g. Ted Talks) which individuals could implement for a course! Interactive resources could also be OER's such as the ones found on phet.colorado.edu. Rajiv then talked about the BC Open Campus website and how some students really enjoyed having open textbooks for the convenience, money savings and ability to have access without payment; one student even mentioned: "I would not have bought the textbook for this course because it's an elective. I would have possibly walked away with a C, now I might actually get an A-," this speaks to the effect OER's could have on student's post-secondary career. He then shared a study, to which he was a part of, which found courses that used both open textbooks and traditional textbooks often don't get statistically different grades on exams other than exam one, where open textbooks do better than traditional textbooks. Rajiv attributes this finding to the fact that students often wait till the first exam, to see if they need to go out and buy a textbook, but with an open textbook, this won't be an issue as it is free. Rajiv speaks upon the "win-win" situation that OER's have for students and faculty. For students, OER's lead to cost savings, access, outcomes and not having the stress of waiting for student loans to come in. For faculty it gives the ability to adapt, update and remix current books. Rajiv also mentiond how OER's increases enrolment into classes because no one is worried about buying a textbook. Finally, he explains how students can advocate and make a change in textbooks in 8 steps.

- "1: Raise awareness about textbook unafforability + availability of OER/open textbooks"
- "2: Collect data about student textbook behaviours"
- "3: advocate to faculty (ask to speak at Department, Faculty, & Senate meetings)"
- "4: Lobby to integrate OER easily discoverable (library catalogue, guides)"
- "5: Lobby for resources to support training, an open textbook review program, OER grant program, institutional policy"
- "6: identify, support, and recognize early adopters"
- "7: Pass a resolution supporting the adoption of OER"
- "8: Lobby to create a campus OER working group"

Rajiv closed off his presentation by introducing "open assignments," in the classroom. He began his talk with mentioning how the paper students spend countless hours on are only read by 2 eyes, graded and never to be seen again. Rajiv mentions that some classrooms edit wikipedia pages for part of their grade, which are viewed millions of times, by students, professors and all other types of people to get background information, or just learn a cool fact. He also mentions that there are courses that even edit open textbooks to make it customized to their own classrooms for part of their grade, which can be more worthwhile for a student to put effort into.

Strategic planning: How to focus your team and get more done:

At this workshop, the discussion started by defining what strategic planning is used for. It is a well known and used moniker but not many people actually plan strategically. The purpose of strategic planning is to allocate resources more effectively and in doing so narrow the focus on the needs of members. Strategy then, is about making choices and considering key questions such as:

-where are we now?

- -where are we going?
- -what will be in the way?
- -what needs to be done?

The implementation of a strategic plan is simply to apply a plan made by few to an entire organization. This requires buy-in for all Board of Directors given that they are the main stakeholders in setting the organization's direction. Creating a strategic plan requires considering multiple factors as well, including external analyses. External analyses include: Strengths, weaknesses, opportunities and threats (SWOT). It also includes consideration for political, economic, societal, technological, legal, and environmental factors (PESTLE). Comparatively, an internal analysis requires input from management teams and stakeholders. Both external analyses requires feedback solicitation such as via surveys, meetings, off site sessions ,and any other creative way to elicit feedback. This should be done prior to the strategic plan's actual development.

Key considerations when doing any outreach or developing the actual strategic plan should be VMOST (vision, mission, goals/objectives, strategies, and tactics). The vision varies by individual organization but should consider operations, staff, clients, and other aspects. It is the blueprint that lays the foundation for everything else so it should be unambiguous. The mission/purpose is how to reach the vision. Goals/objectives should be incremental targets to be reached that can indicate whether the mission and thus the vision is being followed. Strategies are ways to achieve goals/objectives and finally, tactics are specific metrics. In all of the above, remember to consider who is responsible for leadership, communications, resources, etc. so that specific action items can be attributed to individuals and to narrow the focus in achieving the vision. The strategic intent then, should be broad specific themes that are elaborated in the mission and from a top-down approach, end with tactics to assess.

Initiating and implementing new student services:

AMS staff presented on a new service they are developing dubbed the eHub Service (Entrepreneurial hub). The eHub is intended to help new students develop an entrepreneurial mindset. By presenting on this, staff hoped to elucidate upon the process of establishing new services and the challenges that may arise.

In developing any new service, the goal should be to fail fast and early on so there is still time to make changes and experiment with the program. It was recommended to do so in the first four months. Staff argued that the vision should be stationary, as in remain the same so that the target does not shift and thereby cause everything to constantly require changing. Operations ought to follow the vision and success measured by its alignment with mission and vision. As an example, the biggest challenges for the eHub was appeasing stakeholders (UBC Administration) and funding. Funding was resolved by using a peer model (volunteers). UBC

administration's concerns were addressed by aligning with the values and framework important to UBC (they marketed the program as engagement).

The workshop heavily discussed the idea of creative destruction. The founder of eHub emphasized that he created multiple prototypes of his product only for the prototypes to be destroyed by both himself and a panel of judges. He discussed to the importance of leaders to be willing to be 'destroyed' which essentially means that true leaders should always be open to criticism and view feedback as a chance to enhance their performance. He discussed that to be destroyed creatively is the best way for leaders to gain innovative ideas which can fundamentally make both the individual and the idea/case stronger when presented to others.

How governance, people, and dollars lead to success in student leadership: Peter Guo keynote

Several points were discussed in terms of how to create student leadership success. At this presentation, Anthony indicated that governance, people and funding all cumulatively impact engagement. This presentation involved all delegates sharing thoughts on how to incorporate all three aspects successfully in engaging students.

For instance, it was recommended that videos be used to reach out to Council. Council is universally considered a difficult audience for a myriad of reasons. One issue consistent with all Councils is getting people to join and also getting them informed about the society. Other universities also have staff now dedicated to Council for engagement.

AGM attendance was another discussion item. AGMs ought to include food and at AMS, all food outlets are closed with signs on them indicating food available at the AGM venue. They have been able to successfully reach their quorum of 500 through this. All of these ideas cost money so priorities should be set to determine cash flow estimates from the budget.

As for engagement, the key message that should be communicated to students is "what we are doing for students right now". So for instance, instead of office hours, go to student constituency meetings. At SFSS, we no longer have office hours, but we do not require attendance at student constituency gatherings.

Strategic planning and your student union

The main takeaway from this was a 7 step planning process. The rest of the presentation was akin to the earlier workshop except the first one was focused on team collaboration. This one is focused more on overarching goals. The 7 step planning process is as follows:

- 1) Situational analysis
- 2) Mission, vision
- 3) values
- 4) goals
- 5) strategies
- 6) Action plans
- 7) Measurement and adjustment

Situational analyses include PESTLE (mentioned earlier) and SWOT (mentioned earlier) analyses. Mission refers to what and for whom and vision refers to how accomplishing the mission will change current affairs (the possible future). Values are what we stand for, as in how

we act. Goals are the metrics for quantifying where we are headed. It includes the "big hairy audacious goals" (BHAG). These includes those regarding objectives, alignment with pillars, strategic directives, imperatives, and initiatives. Goals ought to be specific, measurable, attainable, relevant, and time-limited (SMART). Strategies are ways that we can achieve the mission or vision. Action plans are specific actions taken that stem from the strategies. Finally, measurement and adjustment is simply as it states, taking additional measurements to see success of current planning process and then to make adjustments where required.

Sponsorship acquisition and strategic partnerships

This session was held by a Kaplan sponsorship representative from SFU. In this session, Kaplan used themselves as an example in explaining how they, like other organizations, may sponsor student union activities under particular conditions. In providing sponsorship, organizations typically do so through in-kind or monetary donations. In-kind sponsorships range from free products, discounts, resources, to influence such as combined efforts in advocacy.

However, the representative also indicated that in turn, organizations like theirs would expect access to communicating with students like through email lists, social media, tabling/space, advertising opportunities, and potentially even feedback mechanisms to receive student opinions. The fact that student unions represent a collective of students is what entices organizations. If we are able to define our student population market's demographics then it further enhances the value that the population has to businesses. This is because it then makes it easier for external companies to know how their products are likely to be received by this market audience. Additionally, having access to them in multiple ways such as surveys and tabling enhances value as well because it provides multiple tactics that can be used to enhance the perception of the products.

Mental health initiatives: Fostering support

In this workshop, AMS staff in charge of their mental health network provided information on mental health generally and also their program. The Mental Health Network is a compilation of resources and the departments/programs that offer them within AMS. They hold joint meetings on a regular basis to discuss how they might partner up and to report any problems or incidents pertaining to mental health that they experienced. Additionally, these meetings serve as opportunities to provide updates to each other on service usage.

According to AMS staff, the first step in fostering mental health support is to identify the issues surrounding mental health and to categorize them in a separate row from suicide risk, sexual assault, and domestic violence issues. Off and on campus resources should then be listed for each. Next, a list of their needs for social, physical health, academic support, financial support, relationships, cultural, and mental health should be identified. Individuals with current or past experiences with mental health should be approached to ask what they have done to resolve the problem(s) in the past, what worked, what didn't work, and what they do for self-care. The list of resources should be compared with the actual needs of individuals to determine

if there is a discrepancy in service and if not, whether these services are meeting the individual's' needs based on self-reports.

In stage two, there should be a classification of risk to determine what levels of support may be required for various people. At the lowest end of the spectrum, individuals should be provided self-help and self-care resources. Next, student clubs should promote mental health through socializing and being active, such as the Mental Health Network at AMS. For more serious issues, peer support and self-care skill-building workshops should be provided to support and help establish habitual coping skills in maintaining overall mental well being. Counselling and professional services are next if the student is any in situation that cannot be resolved by the aforementioned workshops. Finally, emergency 9-1-1 should be dialed for extreme suicidal ideation and to fulfill any statutory obligations where applicable (e.g. risk of harm to others).

Finally, consideration should be made to determine readiness of an organization to respond appropriately to student needs. Discussion should focus on depression, anxiety, suicide risk, sexual assault, LGBTQ+ specific concerns, and domestic violence as disparate categories. There should be a determination of online resources, a hotline (if any) and phone apps or other resources. These lower-barrier support options should be known by all society staff.

Mediation: How to alleviate conflict

In the mediation workshop, a UBC law school graduate present mechanism to alleviate conflict and to mediate situations between two conflicting parties. She discussed the importance of framing. Framing in mediation results in the meditator to reframes the conflict in a neutral manner avoiding any form of emotion when doing so. She also emphasized the use of the word 'miscommunication' when trying to solve a conflict. When a mediator used the word miscommunication it lessens the velocity of the conflict by directly removing the two parties involved and replacing the parties with notion of miscommunication as the reason for the conflict. The key to mediation is to take the blame away from the parties and instead put the blame on intangible objects such as miscommunication. Furthermore, when dealing with two parties that have a prior relation, it is best to use the ongoing relationship as a bridge to relieve the conflict. Putting emphasis on relationship takes the focus off of the conflict and instead puts the focus on a relationship whether it is meaningful or not. However, we need to remember that personal conflicts may take longer than professional when dealing with two parties who have prior relations. In conclusion, the goal of a leader should be to mediate a conflict by removing the emotions of the parties involved and solely focusing on the issue itself.

Ideas and Recommendations:

These ideas and recommendations were either brought up within the workshops by the facilitators or inspirational ideas that were developed from attending workshops. They are as follows:

1) Expand mental health services on campus

- 2) Engage in trauma informed practices
- 3) Host a board development session focused on mediation
- 4) Reconsider policy requirements for mandatory engagement by directors in reaching out directly to constituencies
- 5) Discuss option of having food at our AGMs and to have all campus food operators place a sign saying an AGM is taking place with free food when it occurs
- 6) Sexual assault responding to disclosure training should be received by all society staff and directors
- 7) Develop a board performance evaluation policy
- 8) Develop a sponsorship acquisition SOP
- 9) Expand SFU events to off-campus and also collaborate with other student unions to establish stronger relationships

Action Items:

- 1) Establish a meeting with CEO for progress report on our services evaluation that is being done by staff. Next steps should be to follow through the three stage evaluation of Society services depending on the results CEO provides.
- Discuss with CRPC feasibility of allocating some of the required director weekly hours to engagement
- 3) Meet with President on feasibility of having all campus food operators put up signs when the AGM is occurring, and then consult with SFU Dining and Ancillary Services
- Continue conversations with VP External on providing director training via SFU staff (next steps would be to have staff trained; must consider impact of WC Coordinator leaving)
- 5) Consult VP Finance and CEO on progress update and if none, to begin.
- 6) Consult Bus Rep on standard practice and for documentation. Information will then be formatted to suit and edited by CRPC.
- 7) Conversations with directors from other Student Unions in BC have been started. Currently negotiations are regarding promotions for our Fall Kickoff. Later, there will be joint events both on-campus and off-campus that is funded by all stakeholders (details undetermined).
