THIRD AMENDMENT TO PARTIAL SURRENDER OF LEASE

THIS AGREEMENT dated the 30th day of September, 2020,

BETWEEN:

SIMON FRASER UNIVERSITY, having an address at 8888 University Drive Burnaby, British Columbia V5A 1S6

("**SFU**")

AND:

SIMON FRASER STUDENT SOCIETY, having an address at 8888 University Drive – Maggie Bentson Centre Room 2250 Burnaby, British Columbia V5A 1S6

("**SFSS**")

WHEREAS:

A. By a lease date June 29, 1993 (the "Lease"), between SFU, as landlord, and SFSS, as tenant, SFU leased to SFSS for a term of thirty (30) years, commencing in 1996, and with two consecutive renewal terms of thirty (30) years each, certain premises (the "Leased Premises") or area located in the Maggie Bentson Centre ("MBC") on SFU's Burnaby Campus on lands legally described as:

PID: 028-300-131 Lot 1, DLs 31, 101, 102, 141, 144, 147, 209, 210 and 211 Group 1, NWD, Plan BCP45523;

B. Since the date of the Lease, SFU and SFSS agreed to amend the area of the Leased Premises such that, as of August 29, 2017, the Leased Premises consisted of 5,706 gross assignable square meters ("GASM") or 3,522.6 net assignable square metres ("NASM") in MBC;

C. Pursuant to a partial surrender of lease agreement dated January 7, 2015 (that agreement, together with the amendments thereto dated August 27, 2019 and June 12, 2020, the "**Partial Surrender Agreement**"), a copy of which is attached as Schedule "A" hereto, SFSS agreed to surrender a portion of the Leased Premises comprising 1,903.27 GASM (or 1,174.86 NASM), to SFU effective September 30, 2017;

D. Pursuant to an agreement dated August 31, 2017 (the "Second Partial Surrender Agreement"), SFSS surrendered an additional portion of the Leased Premises comprising 3,241.88 GASM (or 2,001.2 NASM), to SFU effective September 1, 2017;

E. At the time it was signed, the Partial Surrender Agreement contemplated that the Surrender Date may be postponed on the terms and conditions set forth therein, but not beyond September 30, 2019 (the "**Outside Surrender Date**");

F. Pursuant to the amendment dated August 27, 2019, the Outside Surrender Date was extended to June 1,2020;

G. Pursuant to the amendment dated June 12, 2020, the Outside Surrender Date was extended to October 1,2020; and

H. SFU and SFSS wish to further extend the Outside Surrender Date, on the terms and conditions set out herein:

NOW THEREFORE in consideration of the sum of \$1.00 (ONE DOLLAR) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. **Definitions.** Capitalized terms used in this Agreement, including the recitals, that are defined in the Partial Surrender Agreement and not otherwise defined in this Agreement shall have the meanings given to them in the Partial Surrender Agreement.
- 2. Amendment to Partial Surrender Agreement. With effect as of September 30, 2020, the Partial Surrender Agreement is amended as follows:
 - a. Section 6(a) of the Partial Surrender Agreement is deleted and replaced with the following:

"the Surrender Date will not be postponed by more than three months after an occupancy certificate has been issued for the new student union building, and in any event will not be postponed beyond October 14, 2020."

3. Effect of Agreement. The Partial Surrender Agreement is supplemented and amended only as provided in this Agreement. All the provisions of the Partial Surrender Agreement, as supplemented and amended by this Agreement, remain unchanged and in full force and effect and are hereby ratified and confirmed, and time remains of the essence. The Partial Surrender Agreement and this Agreement shall henceforth be read together as if all of the terms and conditions of this Agreement were contained in the Partial Surrender Agreement.

- 4. SFSS's Representations. The SFSS represents and warrants to SFU that:
 - (a) all necessary corporate action on the part of the SFSS has been taken to authorize and approve the execution and delivery of this Agreement; and
 - (b) all of the representations and warranties of the SFSS contained in the Partial Surrender Agreement are true and correct in all material respects with the same force and effect as if made by the SFSS on and as of the date hereof, except to the extent that such representations and warranties specifically relate to an earlier date, in which case they are true and correct as such earlier date.
- 5. **Binding Effect.** This Agreement will enure to the benefit of and be binding upon the parties and their respective successors and permitted assigns.
- 6. **Counterparts.** This Agreement may be executed in any number of counterparts with the same effect as if all parties had signed the same document. All counterparts will be construed together and will constitute one and the same agreement.
- 7. Electronic Transmission. This Agreement or any counterpart may be executed by a party and delivered by facsimile or electronically in portable document format (pdf) and if so executed and delivered this Agreement or such counterpart shall for all purposes be as effective as if the party had executed and delivered the Agreement or a counterpart bearing an original signature.

Condemning Simon Fraser University for Tuition Increases for the 2020-2021 Academic Year

Prepared by Osob Mohamed, President October 2nd, 2020

Tuition has become increasingly unaffordable over the past several decades, as post-secondary institutions rely more on tuition fees for funding, and less on government support. Despite running a significant budget surplus of over \$40M, SFU has decided to increase tuition once again for the 2020-2021 academic year, at a rate of 2% for domestic students, and 4% for international students. Despite the wide reach of student movements such as Tuition Freeze Now, the 2019-2020 proposal to increase tuition 2% for domestic undergraduates and up to 16% for international undergraduates was also approved despite vocal student push back. Tuition fees have more than doubled since 2001, and the average cost of an undergraduate degree has increased by almost \$14,000. [1] This has become a worrying trend in an exploitative system that has not ceased even during the biggest pandemic in our lifetimes.

The COVID-19 pandemic has had devastating impacts for SFU students. Our Spring 2019 Undergraduate survey found that more than 30% of respondents had incurred significant study equipment costs, almost 15% incurring significant travel costs, and approximately 35% of respondents reporting they were unsure of their academic future and ability to continue their studies as a result of their financial position [2]. Students are facing crushing debts, a decimated job market, and being forced to take up employment which may significantly increase their risks of contracting COVID-19. 48.9% of respondents to our Spring survey stated that they are experiencing mental health issues due to COVID-19. The financial and academic challenges students are facing due to COVID-19 pandemic are further compounding the existing mental health challenges they face coping with a pandemic, prolonged isolation, and extreme stress.

The summer semester was a key example of the significantly decreased quality of education at our University. Multiple calls were made from the SFSS and grassroots student groups, such as the SFU COVID-19 Coalition, for SFU to concede the drop in quality of education and implement a tuition deferment and waiver, but these were denied. SFU's 2020-2021 budget draft was provided to the SFSS earlier this year with extremely limited time to provide meaningful feedback, and limited communication to students, staff and faculty on the budget development, amendment and approval process.

The University has claimed that tuition increases go back into student services, awards, and scholarships. In the SFSS's budget feedback provided to SFU's Vice-President Finance and Administration in March 2020, we noted that the portion of the revenue from tuition hikes (particularly from international students) has been increasing at a much higher rate than the funding going into the aforementioned areas (domestic tuition seems to be following a similar trend, likely due to the 2% per year increase cap mandated by the provincial government). A freeze, and subsequent decrease in tuition fees would negate the need to increase funding to areas such as scholarships, bursaries and awards as a result of reduced financial pressures on students.

Undergraduate students make up the largest portion of SFU community members. A condemnation vote passed by the membership would send an undeniable message to the University- that we cannot

and will not allow tuition to increase, particularly during the COVID-19 pandemic. Condemnation votes have been used in student societies and labour unions alike, for the purpose of rallying membership behind a certain issue and sending a strong message to the institution that the membership demands change. A formal, public group condemnation can be a powerful tool in the lead up to a bigger action, and to a direct concession from the University in the near future.

Motion:

Whereas Simon Fraser University undergraduate students have reported unprecedented financial hardship in the face of the COVID-19 pandemic;

Whereas one of the strategic priorities of the Simon Fraser Student Society is to advocate and push for the financial health and wellbeing of our members;

Whereas the Simon Fraser University Board of Governors passed a vote in favour of implementing a 2% increase in tuition for domestic undergraduate students, and 4% for international undergraduate students for the 2020-2021 academic year despite the extreme financial hardship being faced by our membership during the COVID-19 pandemic;

Be it resolved that the Membership of the Simon Fraser Student Society condemn Simon Fraser University for increasing tuition fees by 2% for domestic students and 4% for domestic students for the 2020-2021 academic year.

Be it further resolved that the Membership of the Simon Fraser Student Society formally demands a response from the Board of Governors and University Administration on a plan of action to withdraw the tuition fee increases for the 2020-2021 academic year, and to address the other impacts of the pandemic on undergraduate students.
