5.1 By-Law Review

- Introduction
 - About Council empowerment and holding the Board/Executive Committee accountable
 - Been working on this for the past 3 months to create a resolution to hold the Board more accountable and if it passes, the changes will be made after April 30th, 2021
- Executive Committee
 - Composition
 - Change from 16 members to 7 members.
 - Removing faculty reps to eliminate redundancy and stick with roles that serve ALL students.
 - \circ Powers By-Law 4(4-5)
 - Power to make recommendations to Council for actions it does not have the authority to act on.
 - Example: If Executive Committee created a budget, the Council would be the one to approve it or not.
 - Executive Committee will report its operations at each Council meeting
 - Limitations of Powers By-Law 4(2-4)
 - This change will be a big shift in power, and Council will be taking on most of the current roles of the Board
 - By-Law 4(3-4)
 - Council can restrict Executive Committee powers at any time.
 - Member's Meeting is the new equivalent to AGM
 - Executive Committees will be bound by resolutions made by Council or Membership.
 - This is important because Council is closest level of representation to the student body.
 - Executive Committee is a subset of Council.
 - Their powers come from Council.
 - They will have capacity to do a lot still as the powers and duties of Council can be exercised by the Executive Committee, subject to some regulations & limitations.

• Limitations - By-Law 6(11-14)

- Council is always held accountable by the Membership and cannot go against what they want.
- There are specific date deadlines to meet as listed on the slide.
- Council can only increase or decrease stipends for the next group of councilors.
- Councilors By-Law 6(6)a-h
 - Must act to build up trust among Council and the student body.
 - Must do their best to fulfil promises and fix mistakes as they occur.
 - Must use reasonable efforts to advance interest of the Student Union groups they
 represent as well as for all students.
- Council Committees will be expanded
- Electoral Process

- Council General Elections By-Law 15(27-28)
 - Councilors will abide by the constitution set forth by their own student unions.
 - Council elections occur over a three-week period, and results much be reported to the Independent Electoral Commission by end of week ten in the semester.
- By Elections By-Law 16
 - Occur in accordance with the constitution set forth by their own student unions.
 - Executive Committee Vacancies & Interim Appointments
 - Council may appoint a current councilor into an Executive Committee seat as a temporary position prior to a by-election that must be organized at the earliest possible time except for the President's seat.
 - By-elections to fill vacant offices can only occur in the Summer and Fall semesters.
- Impeachment Procedures
 - o By-Law 17(2&5)
 - Councilor can be removed from Council by 4/5 majority vote of Council or by their membership as their respective Constitutions read.
- Discussion
 - Next action item will be getting at least 10 general members from each Councilor's Student Unions to attend the AGM.
 - Also, will need to discuss and see if Council has confidence in this proposed model.
 - How and why was the 4/5 majority vote to impeach a Council member decided on?
 - 2/3s is too easily abused, which is where 4/5s came in.
 - To safeguard this power from abuse while still having this option available.
 - If the 4/5s majority is not met within Council, the Councilor can still be impeached at a Members Meeting in a 2/3s majority vote.
 - Are there restrictions for impeached Councilor running for re-election?
 - No, not legally able to restrict that.
 - It would be up to the membership.
 - How will Councilor's roles and duties change in relation to their DSUs?
 - Expectation is that Councilor would have to be a separate position, rather than holding several positions.
 - Possibly to have this mandated.
 - Issue with DSUs not having formal Constitutions as well when it comes to removal of Councilors.
 - Will there be a new financial structure for the new Board due to increased work?
 - By-Law notes that Council will receive a stipend and the amount will be set in policy.
 - Because there will no longer be Faculty Representatives and At-Large Representatives, their stipends will be spread-out among the Council. The size of Council will be around a maximum of 60 people.
 - Stipend will work out to about \$100-120 per meeting which is about the equivalent of one workday as Councilors are expected to prepare for each meeting as well.

- What if DSUs are small and might not have enough people to make Council a separate position?
 - Will need to start getting in touch with student unions and helping them grow, as well as departments to set up a student union, if special resolution passes.
 - Should do this whether the resolution passes or not.
 - If it passes, it is likely there will be more competition and interest in being part of Council.
- Psychology Representative, Tiffany Liu, left at 6:08PM.
- How can you be elected to Council Committees and make sure you are sitting on one?
 - Will have to re-write policies to increase the number of committees there are.
 - Will also be absorbing current Board's committees, and there are quite a few of them which will create lots of space for all Councilors to sit on a committee.
 - Challenge will be getting on the committee you want to be on, but you can be on more than one.
 - To get on committees, the Council would select who would sit on what committee via a nominating committee.
- Three methods of impeaching a Council member: DSU, Council and membership Why is there a different group of people that can vote for them and those who can impeach them?
 - Right now, Faculty Representatives are elected by their faculty, but can be impeached by the membership. The idea is that if the society doesn't think they are being represented by a Board/Council member, they have the right to impeach them.
- What is the rush with pushing this through at the upcoming AGM?
 - President who has been involved throughout the process reassures that it has not been rushed and has been very thorough.
 - Acknowledges that they may need to be revisited in the future, but By-Laws are living documents.
 - Chair backs up President, that due diligence has been done.
 - Special Spring AGM would limit the time the current Board has to run elections and work on policies.

- Labour Studies Representative, Justin Chen, left at 6:24PM.
- How does shifting the power from one body to another, bigger body create accountability and fix the problems that the SFSS has now?
 - Composition of the Board will be made up of a more diverse group of students in the new model, and due to number of students there are a lot of people to represent so bigger group is necessary.
 - Very different being the faculty representative and being a part of the DSUs.
 - Had to make Council the Board legally due to the BC Societies Act.
 - This model is quite common for student societies.
- Looking to have a motion next Wednesday to finalize Council's approval for this model so it can be sent to the Board for approval so it can be put on the AGM agenda.
- Note that Councilors will be supported in this transition. There will be a Transition Committee where the Board and Council will collaborate to implement the policies in a way that's supporting everyone.
- The Executive Committee is like the idea makers and the Councilors are like the judicial body who approve or disapprove those ideas.
- Please let the Board know if there's anything they can provide over the next week. Board will be voting on the By-Laws on Oct. 2.
- o Biomedical Physiology & Kinesiology Representative, Josh Ham, left at 6:43PM.
- Previous Boards have dismissed Council so this model will increase student representation.
