7. DISCUSSION

7.1 Renegotiating the FIC Agreement

- Met with FIC, happy to renew, SFSS wants to renew, could do extension and FIC didn't indicate major changes, Q: Whose portfolio? VPs Finance & Ext & Pres.
- Plan out who would attend and get it finished before CA, with overlap of personnel.
- President will set up a meeting in upcoming 2 weeks, who can give insight? Where to start.
- Club support so MSC Coords for feedback, go down the staff list, has FIC requested services?
- FIC can't become Club Execs, a big block to participation in community, participation in elections, needs resolution.
- FIC agreement: What is the pathway to services.
- FIC students as "Associate" members can get UPass and Health and Dental.
- Also with policy modification FIC members can join and lead clubs as Executives.
- FIC survey/referendum for FIC students to see if they actually want to join SFSS.
- Next steps: VP Finance and Ext to join President to meet with FIC.

7.2 Renegotiating the Collective Agreement

- Talks with CUPE indicate post CUPE and SFSS AGMs.
- Challenging with the number of changes, though the CA did work under a similar Council 'model'.
- New SUB will bring to bear job categories, hours, classifications.
- Need a lawyer and start a conversation?
- How it works: CUPE will come with a 'locked' and ratified package.
- Timelines not during exams, as many have courses, if not before final maybe beginning Jan 2021.
- CUPE has suggested a short, straightforward 'package'.
- HR & P can strike the Negotiating Team.

7.3 Hiring SFSS Support Staff for Equity and Advocacy Initiatives

- Board has approved various advocacy roles.
- In Spring, Board will need to focus on these positions.
- CPR Coord can be a good resource for building JDs and postings.
- Where is Student Advocate (LJ to forward to CUPE the Advocate position).
