Recommendation	We recommend that all current and past board members, including council, and the executive board refrain from participating in the election in any manner public or private. This is due to the fact that it challenges our autonomy as Independent Commissioners, since there were malicious attempts to influence our decisions due to the fact they are in a position of power. Furthermore, it is unfair and unjust to other candidates since they may not have such expertise due to not running before in any election cycle.

FINAL THOUGHTS

The continued online environment has posted some persistent challenges to the work of the IEC. Being able to apply my previous elections experience as a Chief Commissioner has been paramount to conducting a smooth and successful election despite all the challenges. Some of the challenges we faced as a team included an increase in tumulous banter among candidates which really posed some difficulties in finding the right balance of neutrality. There was also another challenge posed to the IEC regarding finding actionable evidence when complaints were filed to ensure the elections process was free and fair. The recommendation from the IEC would be to foster a closer sense of connection with the candidates, staff, and the general student society population as a whole.

I wish the upcoming commissioners the best and hope that these points were useful.
