SUBMISSION INSTRUCTION

REQUIREMENTS

1. Each section must be complete and legible. Incomplete or illegible information will not be considered.

HOW TO SUBMIT THE PACKAGE

1. If the referendum question is submitted by the Executive Council, ensure the Executive Committee minutes approving the referendum question are attached to the package.
2. If the referendum question is submitted by Council, ensure the Council minutes approving the referendum question are attached to the package.
3. If the referendum question is submitted by the Executive Council, following the receipt of a Petition for the Submission of a Referendum Question, ensure that:
 - a. the petition is attached to the package, and
 - b. the Executive Committee meeting minutes during which the petition was submitted are attached.
4. If you are the Executive Council or Council liaison for the referendum question, send a completed package to the Independent Electoral Commission's Chief Commissioner at elections.chief@sfss.ca.
 - a. Monitor your email for message from the Independent Electoral Commission regarding the approval status of the question.

DEADLINES AND ADDITIONAL INFORMATION

The deadline for the submission of referendum question packages and any additional information may be found online at <http://sfss.ca/elections/>.

During the election and referendum periods, question may be submitted by email to the Chief Commissioner of the Independent Electoral Commission at elections.chief@sfss.ca or by visiting during office hours.

Outside of election and referendum periods, questions may be submitted by email to Policy, Research and Community Affairs Coordinator at policyresearch@sfss.ca.
