## SUBMISSION INSTRUCTION

### REQUIREMENTS

1. Each section must be complete and legible. Incomplete or illegible information will not be considered.

### HOW TO SUBMIT THE NOMINATION PACKAGE

#### **In-Person at the Student Centre** \*Please note this process is suspended for 2022 due to the COVID-19 pandemic\*

1. Go to the SFSS Student Centre.
2. Present the complete Nomination Package to the staff at the front desk. Please note that the hours of the Student Centre are Monday to Friday, 10 am to 4 pm PST.
3. Sign the drop-off tracking sheet record.
4. Monitor your email for message from the Independent Electoral Commission (IEC) regarding the status of your candidacy.

#### **In-Person to the IEC Chief Commissioner** \*Please note this process is suspended for 2022 due to the COVID-19 pandemic\*

1. Visit the IEC during their office hours, as posted on sfss.ca.
2. Present the complete Nomination Package to the Chief Commissioner.
3. Sign the drop-off tracking sheet record.
4. Monitor your email for message from the IEC regarding the status of your candidacy.

### Online

1. Submit your complete Nomination Package to the Chief Commissioner at [elections.chief@sfss.ca](mailto:elections.chief@sfss.ca).
2. Monitor your email for message from the IEC regarding the status of your candidacy.
