SUBMISSION INSTRUCTION

REQUIREMENTS

1. Each section must be complete and legible. Incomplete or illegible information will not be considered.

HOW TO SUBMIT THE PACKAGE

- 1. If the referendum question is submitted by the Executive Council, ensure the Executive Committee minutes approving the referendum question are attached to the package.
- 2. If the referendum question is submitted by Council, ensure the Council minutes approving the referendum question are attached to the package.
- 3. If the referendum question is submitted by the Executive Council, following the receipt of a Petition for the Submission of a Referendum Question, ensure that:
 - a. the petition is attached to the package, and
 - b. the Executive Committee meeting minutes during which the petition was submitted are attached.
- 4. If you are the Executive Council or Council liaison for the referendum question, send a completed package to the Independent Electoral Commission's Chief Commissioner at <u>elections.chief@sfss.ca</u>.
 - a. Monitor your email for message from the Independent Electoral Commission regarding the approval status of the question.
