

# 6.1 Snack and Drink Reimbursement after meeting with Federal MP- MOTION ECA 2023-03-31:03

# 7.1 Concerns from Jews student association about Campus Space

- The Environmental Science Councillor mentioned that they thought ECA is the right
  place to bring this up. SFU 350 has a protest and were shut down by the SFSS. SFSS has
  written an apology and is working really hard on it to make sure they get clarity on
  protests in the building and protocols regarding staying safe when similar things are
  happening.
- They mentioned that similar thing happened during February when JSA were trying to host workshop in the SUB and there was a disruption and were asked to leave. Last week they put out a statement to draw attention to this event and how their group is being treated as compared to SFU 350 as that group had received an apology letter but nothing is acknowledged for their group.
- They mentioned that they wanted to bring this to ECA to ensure something is done to acknowledge their group as well.
- The VP External mentioned that in terms of next step, JSA can put an email to executives and they can talk about it from there. They can look into statements on what happened. The difference in SFU 350 group situation here is that they put out an statement after their protest and they responded to it and they were at SFU at that time when this happened so this is one of the reason the response to it was quicker.
