Whereas situations have occurred since the SUB's opening where executive officers needed to access the SUB outside of operating hours but could not;

Be it resolved that the Executive Committee approve allowing executive officers to access the building outside of regular operating hours as needed to perform work."

Whereas, situations have occurred since the above motion where executive officers needed non-executive officers to access the SUB outside of operating hours but could not,

Be it resolved that:

The Executive Committee also approves granting access to non-executive officers, i.e. committee members, students, and volunteers to the SUB outside of regular operating hours as needed to perform work.

The access granted to non-executive officers outside of operating hours shall be in accordance with the guidelines and policies set forth by the SFSS, and shall not infringe upon the rights and privileges of other committee members, students, volunteers, or individuals assisting in the organization's activities.

The access granted to non-executive officers outside of operating hours shall be based on the nature of their work and the requirements of the organization, as determined by the executive officers.



All individuals granted access outside of operating hours shall be responsible for ensuring the security and proper use of the SUB during their access.

The executive officers shall be responsible for coordinating and overseeing the access provided to non-executive officers outside of operating hours, ensuring appropriate records and documentation are maintained.

Aside from the 24-hr access fobs already provided to executive officers and appropriate staff, no additional 24-hr access fobs will be provided to non-executive officers; individuals entering the building outside of operating hours will only do so at the discretion of executive officers. **CARRIED UNANIMOUSLY**
