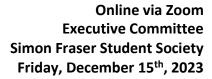

- Ricky shared that the insurance company would not cover clubs that engage in gambling whether real or perceived. The use of chips, points or tokens to make wagers count as perceived gambling.
- Samantha added on that the club coordinators won't be able to closely monitor the
  club's activities for gambling. It is also uncertain if SFU would allow the mahjong club to
  host events in their spaces or if a gambling license is needed. She stated that SFSS
  would be taking too many extra steps to make the mahjong club work within the
  policies and guidelines currently in place. The approval of the mahjong club would
  create the opportunity for students to start the blackjack, poker, and other gamblingassociated clubs.
- Acting VP Internal and Organizational Development shared that the committee should trust the expertise of the staff. They also added that the mahjong club would only be able to book within the SUB if SFU does not provide their spaces. This would negatively affect SUB room bookings and the staff handling it. They moved to postpone the item indefinitely.
- VP External and Community Affairs suggested having a thorough conversation with the students creating the mahjong club. She also moved to postpone the item indefinitely.
- VP Events and Student Affairs shared that they understand that mahjong is related to gambling but doesn't think this is a good reason to turn down the approval of the club.
   He believes they have the responsibility to at least talk to the students about the appeal and see if the club could work.

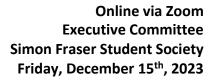

Be it resolved that the SFSS formally expresses its concern about the oversight in the Gender Action Plan regarding post-secondary education; a letter be drafted, detailing the SFSS's position and other societies on the matter, highlighting the need for specific adjustments and enhancements in the Gender Action Plan to adequately cater to the requirements of post-secondary students;

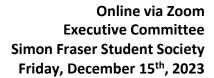
