Whereas the Governance Committee reviewed and discussed these changes on October 30th, 2023;

Be it resolved that the Governance Committee recommends to Council to approve the changes to the Simon Fraser Student Society's Finance Policy outlined in attachment SFSS Finance Policies 2023-10-30 Fees Updated- Pending Formatting edits from VPIOD and Temp. Operations Organizer.

VP Finance requested a copy of the agenda, Acting VP Internal and
 Organizational Development requested MBBSU Councillor to send the



agenda which they did.

- Acting VP Internal and Organizational Development shared a screen showing the Finance Policy and requested either the Temporary Operations Organizer or the VP Finance to explain more on what the policy was about.
- Temporary Operations Organizer shared this needs to be updated because there have been a lot of changes and a lot of policies need to be reviewed.
- Acting VP Internal and Organizational Development shared that shared that they would start off with 1.8 and asked Temporary Operations Organizer what about the schedule is to be discussed.
- Temporary Operations Organizer shared this was the updated fee schedule showing the current year and current year fees.
- Acting VP Internal and Organizational Development shared they believed this should be in alignment with FASC.
- Acting VP Internal and Organizational Development asked for clarity as to why 1.11 was crossed out.
- Temporary Operations Organizer confirmed it was identical to previous notes so that was to reduce redundancy.
- Acting VP Internal and Organizational Development asked for clarity on a comment on 1.17 was crossed out to which Temporary Operations Organizer shared it was about changing the date to in May.
- Acting VP Internal and Organizational Development made the changes and moved on to 1.20 which was deleted.
- Acting VP Internal and Organizational Development moved to 2.4.
- Temporary Operations Organizer asked for clarity from FASC and Governance because she was not sure what the intent of this was and if anyone had the interpretation of this was, they should share.



- Acting VP Internal and Organizational Development asked VP Finance what their Interpretation of it was.
- VP Finance shared they did not receive a brief on this.
- Associate VP Internal replied he believed this might be the condition to
 where someone can pay fees to remain a member of SFSS while not taking
 courses, and the second half says paying their fees does not make them less
 of a priority as opposed to someone taking undergraduate classes and
 Associate VP Internal shared that this was so vague and was not sure of their
 Interpretation.
- MBBSU councillor shared it does not affect the membership status.
- Associate VP Internal, MBBSU councillor, and Acting VP Internal and Organizational Development agreed this policy was worded vaguely.
- Temporary Operations organizer agreed that if governance committee wanted to re-word it, they could do that.
- Acting VP Internal and Organizational Development moved on to 2.5
- Temporary Operations Organizer shared she changed all general offices to student offices to Student Centres because that is what they are now and suggested there may be reference to forms hat don't exist of maybe exist but are never used and would like to check in with governance on how thy should continue to exist.
- Acting VP Internal and Organizational Development shared if what we are using now is working then we could stick with that and the policy would only need to change to reflect current procedure.
- Temporary Operations Organizer shared that right now it is using emails.
 The change required would be removing the references to the forms.
- Acting VP Internal and Organizational Development removed 2.6



- Acting VP Internal and Organizational Development moved to 3.5, that required a name change and adding of groups.
- Acting VP Internal and Organizational Development moved to 3.7.
- Acting VP Internal and Organizational Development asked VP Finance about 3.9 (c) regarding moving investments.
- Temporary Operations Organizer shared that the policy can be removed since it is not being followed and it exists in a different format.
- MBBSU councillor asked which budget this was and if it was contingency funds.
- Temporary Operations organizer shared it was in an internally restricted account that was moved to investments.
- MBBSU councillor asked if this was SFSS's only contingency fund in case of emergencies or this was another.
- Temporary Operations Organizer suggested changing the wording.
- MBBSU suggested that an Internally restricted contingency fund should remain in case of emergencies and that could be looked at further in a separate discussion.
- Associate VP Internal did not understand the purpose of an additional contingency fund and would like to know in order to show support.
- MBBSU Councillor asked if there was a contingency fund for legal to which Temporary Operations Organizer replied there was one. MBBSU Councillor shared he had no more dissent.
- Acting VP Internal and Organizational Development moved to 4.2
- Acting VP Internal and Organizational Development moved to 4.4 and asked Temporary Operations Organizer to clarify on how FASC would like to proceed.



- Temporary Operations Organizer shared it is proposing reviewing of budgets to start now as it is November, however that has not been feasible and other options would be better.
- Associate VP Internal suggested wording can be changed so it can depend on the circumstance heading into the next year.
- Temporary Operations Organizer shared there is a by-law and policies in council with deadlines for submissions so a schedule exists.
- MBBSU councillor requested leaving the policy in for future reference and not make the policy mandatory.
- Acting VP Internal and Organizational Development agreed and suggested Section 4.4 was renamed "Recommended schedule" and making it nonbinding and base the decision to use it on existing circumstances.
- Acting VP Internal and Organizational Development moved on to 4.10 which was removed.
- Acting VP Internal and Organizational Development moved on to 4.16 which was removed.
- Acting VP Internal and Organizational Development moved on to policy 5 which was removed.
- Acting VP Internal and Organizational Development moved on to 6.5 which was removed.
- Acting VP Internal and Organizational Development moved on to 6.6 which was changed to "... any signing authorities."
- Acting VP Internal and Organizational Development moved on to 7.1 and its language was changed to reflect the use of one credit card which is how the process is bring done now.
- Acting VP Internal and Organizational Development moved on to 7.6 and



- 7.7, which were removed.
- Acting VP Internal and Organizational Development moved on to 7.10
- Acting VP Internal and Organizational Development asked where Finance policy 8 was to which Temporary Operations Organizer shared it was a missed number.
