# INTRODUCTION

The SFSS has historically used the term referendum during elections and by-elections, and resolution (ordinary or special) to refer to resolutions as per the Societies Act of B.C. during member meetings.

The following document provides a history of all SFSS resolutions and referendum and their results (collectively referred to as referenda in this document), as voted on by the membership from 1966 to 2023. This report organizes resolutions by the date they were passed by the membership, not the date that they were accepted and officially ratified by the provincial government in the case of by-law and constitutional amendments. Information has been gathered through Society records and Peak archives. The document is divided into two sections beginning with referenda that were passed and then referenda that failed. Each section will provide a list, description and breakdown of the referendum passed and failed.

Description:

- Be it resolved that by-laws 13 (2) b, 13(4), 13(5)b, 13 (8)c and 11 (18) be amended to read as follows:
- 13 (2) b) the delivery of a petition to the student forum containing the signatures of no less than 50% plus one of the number of members of the department who voted in the election for that position, or, 100 members of the department, whichever is the lesser, and which contains a statement of the specific charge(s) against the student departmental representative.
- 13 (4) Quorum for a meeting called to consider impeachment of a Student Departmental Representative shall be 66% of the number of members of a department who voted in the election for that position or 10% of the members of the department represented by the Student Departmental Representative, whichever is the lesser. (a, b, and c remain the same).
- 13 (5) b) The delivery to the Student Forum of a petition containing the signatures of no less than 50% plus one of the number of members who voted in the election or 5% of the Student Society, whichever is the lesser, and which contains a statement of the specific charge(s) against the officer in question.
- 13 (8) c) Should less than 66% of the number of members who voted in the election for the “at-large” position vote in the referendum, or less than 5% of the student body, whichever is the lesser, the impeachment proceedings shall cease. Otherwise, a

2/3 majority of those voting shall be required to impeach an “at-large” officer. Upon such a resolution being carried by the majority indicated, the officer so impeached shall be deemed to have delivered his/her resignation.

- 11 (18) Voting shall take place on a day selected by the Electoral Standing Committee in the Fall Semester no sooner than two full weeks following the close of nomination. Polling for all positions shall occur between the hours of 9:30 am and 7:30 pm.

### **By-Law Change Ombudsperson**

Description:

Amendments to by-law 7, section (3), by-law 11, section (2), by-law 13, section (1), by-law 13, section (9) and by-law (20).

Amendments include replacing existing sections with:

The ombuds office shall be an agency autonomous of the SFSS, for the members of the SFU community. It shall consist of at least one ombudsperson. The Ombudsperson shall not represent or otherwise exercise powers of the SFSS forum, nor shall the SFSS represent or otherwise exercise powers of the Ombuds office.

- u. The ombudsperson shall be required to be available on a regular basis to students and other students and other members of the University community to serve as a source of information and assistance with respect to academic and any other University related rules, regulations, policies and procedures. This shall include, but not limited to, counselling students regarding various University procedures.
- v. The ombudsperson shall be entitled to investigate any issue concerning SFU or the SFSS which directly affects any member of the university community.
- w. The ombudsperson shall endeavour to ensure that all matters presented to the Ombuds Office are dealt with, and that agencies of the University or the Society are contacted as appropriate.
- x. The ombudsperson shall not hold any elected position on campus. The ombudsperson shall not hold any other appointed position or employment in the society or any affiliate organization of the society.
- y. The ombudsperson shall be entitled to access to all files, business reports, and all records of the society.
- z. The ombudsperson shall have the right to be recognized and to speak at any General Meeting of the society, and shall be recognized to speak and attend any general meeting of the society but no vote.
- aa. It shall be incumbent upon the members of the student forum to ensure that the position of the ombudsperson remains filled.

Any member of the Society requesting a Special General Meeting for the consideration of a proposed amendment, provided that the proposed amendment shall be accompanied by a petition setting out the text of the proposed amendment and requesting a Special General Meeting for its consideration and accompanied by the signatures of not less than five percent of the members in good standing of the Society.
  - i. Amendments to be voted on by referendum may be initiated in accordance with Bylaw 17(3).

The agreement must guarantee the following:
  - a. The Society's membership in the organisation does not preclude the Society's membership in other organisations.
  - b. The organisation will make its by-laws, policies and minutes available online to all members of the Society within three (3) months of their approval.
  - c. The organisation will, within two (2) months of receipt of a written request from any member of the Society, provide to them a copy of any document in care or control of the organisation not lawfully required to be kept private.
  - d. The organisation recognizes that the Society reserves the right to terminate its membership in the organisation according to the Society's by-laws and policy and according to any of the following procedures:
    - i. by resolution of the Board if the Society joined the organisation by resolution of the Board;
    - ii. by resolution of a General Meeting if the Society joined the organisation by resolution of the Board or by resolution of a General Meeting; or
    - iii. by referendum in any case conducted in accordance with By-Law 17.
- 2. If the Society terminates its membership in an organisation as described in By-Law 22(1) by any means other than referendum,

and if the Society normally collects a membership fee from its members on behalf of that organisation and remits it to that organisation, then the Society will immediately cease collecting fees.

- 3. If a resolution is put to referendum to terminate the Society's membership in an organisation as described in By-Law 22(1), and if the Society normally collects a membership fee from its members on behalf of that organisation and remits it to that organisation, then a resolution to cease collecting the membership fee shall be automatically put to referendum according to By-Law 17 to occur concurrently with the referendum on ceasing membership in the organisation.

- 6. The referendum shall be conducted by the Independent Electoral Commission in accordance with By-Law 14.
- 7. Due notice shall be deemed to have been given by compliance with the provisions of By-Law 10.3 relating to notice.
- 8. No referendum shall be deemed valid or binding on the Society unless a minimum of five (5) percent of the members in good standing of the Society have cast ballots in the referendum.
- 9. The Independent Electoral Commission shall report on the conduct and results of the referendum to the Board for ratification

### **Approval of a Debenture in Respect of the Construction of a New Student Union Building and Stadium**

Description:

A. Whereas the Simon Fraser Student Society (the "Society") and Simon Fraser University ("SFU") have agreed to enter into a project (the "Project") for the construction of a new student union building and stadium on SFU's Burnaby campus.

B. Whereas a referendum was passed by the members of the Society (the "Members") on March 22, 2012 in favour of the development of the Project.

C. Whereas the Society will need to borrow money from third parties to fund the development of the Project and is seeking such financing on the best available terms. In order to obtain such funding, the Society may be required to grant or issue security, in the form of a debenture, promissory note, mortgage, general security agreement or other security instrument, for the repayment of any amount so borrowed.

D. Whereas the Society's bylaws (the "Bylaws") provide that its directors (the "Directors") may, for the purpose of carrying out the purposes of the Society, borrow, raise or secure the repayment of money and may authorize the issuance of security on the whole or part of the property or assets of the Society, present and future, including Society fees now or hereafter due or payable, except that no debenture shall be issued without sanction of a special resolution.



E. Whereas the Society Act (B.C.) similarly requires that any issuance of a debenture by the Society be approved by the Members by special resolution and permits the Members to grant a general power on the Directors to issue debentures for a period of one year from the date on which such resolution was passed.

F. Whereas it is expedient for the purposes of facilitating the Project that the Members exercise the authority conferred upon them under the Society Act (B.C.) and the Bylaws by giving the Directors the authority to borrow such amounts as may be required in order to pursue the Project and to secure the repayment of such borrowing in the manner that the Directors see fit. Be it resolved that:

- 1. The Directors are hereby authorized, for a period of one year from the date hereof, on behalf of the Society, to borrow from such persons, firms, corporations, societies, cooperatives, credit unions, trust companies, banks or other lenders as they deem desirable, such amounts as are determined reasonable or necessary by the Directors for the purposes of the Project, on such terms as the Directors may from time to time approve.
- 2. The Directors are hereby further authorized, for a period of one year from the date hereof, on behalf of the Society, to secure repayment of any and all borrowing done for the purposes of the Project in such manner as the Directors consider to be in the best interests of the Society, including, without limitation, by the creation, granting and/or issuance of debentures, promissory notes, mortgages, general security agreements and such other security instruments charging all or any portion of the real or personal property of the Society, all on such terms as the Directors may from time to time approve, without further authorization from the Members.
- 3. Any two Directors or officers of the Society are hereby authorized to execute on behalf of the Society, under seal or otherwise, any agreement, debenture, mortgage, security agreement or other instrument that such person deems necessary or desirable to effect any borrowing by the Society or to give and perfect any security granted by the Society.

All SFU students are members of SFPIRG, and contribute a member fee every semester as part of their Activity Fee. All SFU students currently contribute \$3 per semester, except students taking 3 credits or fewer who currently contribute \$1.50 per semester. This member fee was last set by referendum in 1994. The inflation rate in BC from 1994 to 2019 was 45.03%, meaning that something that cost \$3 in 1994 would now cost \$4.35 significantly impacting SFPIRG's operating budget.

SFPIRG needs additional revenue to maintain current levels of programming and services, to expand and enhance the organization's scope and capacity, and to adjust for the inflation that has occurred over the last 25+ years. Without there being an increase, SFPIRG would not be able to continue operating at current levels, nor continue growing and developing new programs, services and opportunities for students.

- Be it resolved to increase the student levy for SFPIRG to \$5.50 per semester for students, except students taking 3 credits or fewer who would contribute \$2.75 per semester, adjusted annually for inflation according to the Vancouver Consumer Price Index (CPI).
