#### 10. PRESENTATION

#### 10.1 Solidarity for Iranian Community

**SUBMITTED BY:** Acting VP Equity and Sustainability "Arthur Lee"

**PRESENTED BY:** Yasamin

- The Islamic Regime lowered the age of marriage for women from 18 to 13 (in 1979)
- and then to nine (in 1982).
- A married woman cannot leave the country without her husband's permission.
- Women are not allowed to watch men play sports at stadiums.
- Single women can't check into a hotel.
- A man can marry up to four women at once; women can only marry one
- husband. A woman needs a male guardian's consent from her father or paternal
- grandfather to marry.
- Muslim women cannot marry non-Muslim men, while Muslim men can marry
- Jews, Christians or Zoroastrians.
- Women can only get a divorce in court, while a man can get a divorce simply by
- verbally declaring it and not even in her presence.
- A divorced woman can not get her child's custody.
- When a parent dies, the daughters' inheritance is half of the sons.
- A widow woman gets only one-eighth of her husband's inheritance, even with
- no child, the brother or the father of the man will get the rest.
- The Islamic Republic mandated wearing a head covering, or hijab, in public.
- Violators face punishments.
- A few days ago, a 22-year-old girl got arrested by "the mortality police" for not wearing her hijab tight enough while she was visiting the capital of Iran, Tehran; soon after, her family was informed that she was in a coma in a hospital due to "previous health"



problems."

- Her family denied any previous health issues. She DIED in the hospital. Her skull scan showed a skull fracture and massive hemorrhage after getting beaten. Her name was MAHSA AMINI.
- This triggered a huge protest in different cities in Iran. The protesters wanted justice for Mahsa Amini and hundreds of other Iranians who got murdered and arrested by the IRGC for no good reason.
- The mortality police never confessed to their crime, and in reaction to the protests, they shut down the internet massively. In the streets, they killed several protesters just to prove that they did not kill Mahsa Amini.
- In reaction to protesters, a governmental professor stated, " Prostitutes
- mourn a prostitute." The protests continued in the streets; this time, the protesters
  wanted death for the dictator and the terrorist government of the Islamic Republic of
  Iran.
- The IRGC continued to kill more and more protesters, including Hadis Najafi, a 20- yearold girl who got murdered by six bullets, and Nika Shahkaram, a 17-year-old girl who got kidnapped, then raped and tortured several times before getting murdered by the IRGC.
- So far, the murder of 154 civilians has been confirmed by the human right organization.
- The protests are still in progress in Iran, and the IRGC uses children to kill protesters.
- Last Friday, on September 30, 2022, the people of Dezap gathered to protest the rape of a 15 years old Balochi child by an Iranian commander in Chabahr, south Balochistan.
- As people were demonstrating during Friday's prayers in Dezap, the Iranian military forces struck the civilians and showered them with real war bullets and shut down the internet completely.
- So far according to the Campaign of Baloch Activists, 88 civilians including four children (12 to 16 years old) are reported dead and more than 300 injured, some of them are in crucial condition. the numbers are likely to increase.
- Locals reported that the Iranian military forces were shooting at protesters in Dezap with helicopters.
- The protests in Balochistan continue and have spread to other areas. Many areas of Dezap are under people's control after three days of protests. An informed source told the Campaign of Baloch Activists that There is an urgent need for blood in Dezap hospitals, and many wounded have died due to severe bleeding.
- After the protests of Iranians in more than 150 cities in the world on October first, in response, the IRGC surrounded the Sharif University of technology, the most prestigious university in Iran, and prevented the students from getting out. The military force beat them, abused them, harassed them, shot them and slaughtered them. Many civilians tried to enter the university to help the students, but there was no trespass.
- The IRGC shoot into students' dormitories and shut down the internet there.
- After that night, everybody in the university either got wounded or arrested. There is no



further information about the most intelligent students of Iran.

- The murder of Jina 'Mahsa' Amini on 16 September, 2022 by the repressive Iranian government force known as the "morality police," has sparked demonstrations in every corner of the world. "Zan, Zendegi, Azadi" Woman, Life, Freedom inspired by the revolutionary Kurdish "Jin, Jiyan, Azadi," can be heard in every city with an Iranian community.
- From Kurdistan to Sistan-Baluchestan, from Mazandaran to Fars, and despite violent crackdowns on protestors by the government forces, Iranians are determined to end the oppression of women, workers, ethnic minorities, and queer communities. "Zan, Zendegi, Azadi," embraced by Iranians of all stripes, represents a movement that is anything but a single-issue struggle.
- Led by Iranian women, the streets and schools of many cities in Iran, whether in Tehran, Sanandaj, or Zahedan (where more than 80 unarmed civilians were massacred on Friday, 30 September), are battlegrounds for the war against femicide and the patriarchal power that enables it. The strength of the movement is in the clarity of its message: there is no life or liberation for anyone without women's liberation. The right to choose whether to wear a headscarf is central, but not all encompassing; the movement demands more. Iranian students, teachers, and faculty responded to the call from the streets, and extended the people's struggle to the campuses and schools.
- A state of siege has encapsulated the student movement, in a very literal sense. Iranian students and faculty in some universities, Sharif University of Technology for example, have been cut off from the outside world; facing the wrath of the government, they are targeted, cornered, beaten, arrested, and shot at. The murder of their peers, coupled with the threat of detention, has imposed a specter of dread throughout Iranian university campuses. With every escalation, the regime betrays its true character: murderous, exploitative, and full of fear. The unwavering courage of Iranian students, teachers, and scholars in resisting state repression, as the cost for such acts of protest continue to rise, need to be met with international support and solidarity.
- We hope to sustain the pursuit of the Iranian people for self determination and emancipation from patriarchal domination by supporting, to the best of our ability, Iranians at home and in the struggle. It is in light of these circumstances that we urge Simon Fraser University (SFU) and the University of British Columbia (UBC) to act accordingly and continue to support Iranian students, staff, and faculty by committing to the following requests:
- Official Academic Recourse: An official statement by the university leadership of SFU, in
  consultation with the Iranian student body, on behalf of the university, condemning the
  mass arrests and killings in Iran, especially on university campuses;
  Advocacy by the university leadership of SFU and UBC for the immediate release of
  Iranian student prisoners;
  Statements by the Deans, Department Chairs, and School Directors issued internally to



their units in solidarity with their Iranian students, staff, and faculty; and Consider declaring state-affiliated university officials involved in the violent repression of university students in Iran 'persona non grata,' excluding them from university-run academic activities, conferences, and fora.

- Admissions and Iranian Applicants: Increase flexibility in admission requirements, especially those concerned with TOEFL/IELTS examinations; Remedial measures for starred\* student applicants; Waive admission application fees for Iranian students at risk; and Extend the deadline for admission applications for Iranian student applicants.
- Academic Community Support: Support and accommodate Iranian students, RAs, TAs, and TMs, and faculty during these challenging times; Increase access to adequate and robust mental health resources for Iranian students at SFU and UBC; Provide funding and spaces for public gatherings, conversations, and dialogues on the current women's liberation movement; Provide funding for research by and for marginalized Iranian communities; and Provide funding for Iranian cultural and community programs, events, and classes.
- In solidarity with the Iranian people, In solidarity with the women of Iran, In solidarity with the Indigenous peoples of Turtle Island, In solidarity with the all the struggling women of the world, Until liberation.



# 11.2 SFSS Statement in Solidarity with Iranian Community- MOTION COUNCIL 2022-10-12:08 SUBMITTED BY: Acting VP Equity and Sustainability "Arthur Lee" Helen / Eshana

Whereas protests have erupted across Iran to protest against the death of 22-year old Mahsa (Zhina) Amini;





Whereas reports have shown that the authority in Iran are directly involved in silencing, misdirecting the public, and shutting down communication systems across the country;

Whereas, as a organization, the Simon Fraser Student Society (SFSS) is committed to stand in solidarity against any violent actions against women and any other minority groups;

Whereas the Iranian community within SFU has issued a statement asking the SFSS to condemn the assault on students, faculty, in Iranian universities, as well as other protesters across Iran;

Be it resolved to task the Acting VP Equity & Sustainability to draft a statement condemning the actions of the Iranian government.

# 11.3 SFSS apology for Harmful Statements and Commitment for More Education- MOTION COUNCIL 2022-10-12:09

Whereas Council was not provided with adequate information to take an informed decision on a proposed monetary donation of \$10,000 to the Indian Residential School Survivors Society (IRSSS); thereby limiting its ability to act in accordance IP-7 of SFSS policies and Indigenous students on campus and in the community;

Whereas Council acknowledges its misstep and commits itself to improvement through education and greater conscientiousness in proceedings in future;

Be it resolved that SFSS directs the Executive to work with the VP Equity and Sustainability to organize workshops on Indigenous Reconciliation for the Membership and Councillors to bring Council in alignment with IP-7 and Council's commitments to Truth and Reconciliation

#### **CARRIED AS AMENDED**

- Philosophy abstained.
- One of the Member mentioned that members of society used false came to ruin the
  reputation of our VP External and FNMISA, and RSSA. The members showed last of
  empathy and understanding towards truth and reconciliation and recommend to
  have more information been done in regards to indigenous history. They expect the
  chair to hold values in regards to restricting the comments from certain member.
  They mentioned that Mark Giles from PSU called it either fraudulent or incompetent



and Emilio Da Silva from GSSU were discrediting things that were not related.

- They mentioned that the annual report from the website it up and they can provide the link to council as it is up since April. The organization are easy to contact.
- Comments made by the Acting GSSU Councillor regarding the money going externally and not to people, it is politically damaging. It is okay to be against but some of these comments were not positive and helpful to the conversation and they feel that the chair of the meeting should have stopped it.
- The SUS Councillor mentioned that when we engage in conversations, not everything
  is positive and there are always opposing sides to the organization. Secondly, there
  were no claims made against the indigenous people of being predisposed to fraud or
  any negative comments to the indigenous community.
- The only questions that were asked were that we were not aware of this organization before hand. This proposal for the donation came 16 hours before the meeting took place. People did not know where the money will go. If we still say yes to the annual donation of such big amount, the person who got this motion ahead should have provided more clear information and it is not on us.
- Also, if we were skeptical to donate to an organization that does not mean that we are against any community or indigenous people. They are standing against donations to an organization they are not aware of so in the end it does not lead to no effort made to the community. We are a diverse group of people in the Council and they have little background on indigenous community and organization. We just knew that we are making a donation, we did not know where they money is going.
- The President reminded the Council to be mindful of what they say as this is a sensitive conversation and they ask everyone the space to feel safe in these conversations no matter if anyone agrees or disagrees.
- MBB Councillor mentioned that they are an indigenous student and they have personally felt the trauma of residential school system and they get where one of our members and FNMISA is coming from. However, they do not think that the comments that were made last meeting were racist at any form.
- There were legitimate questions such as asking for an annual report that meeting before making decision to donate and approve. And, nothing was given up before we were making the decision. It is on our VP External who got this motion and they did not come with that prepared. We just cannot give our students money to anyone. We want to ensure that the charity does what it says and actually help indigenous students. Looking now and with the information provided today they are comfortable with the donation. But, at that time they were not.
- In response to one of the members our VP Internal mentioned that logistically, we can do more moderation with the council meeting specially as we did the past few months. But, they are concerned with the idea that how the chair would know what to shut down and what to not shut down. There needs to be a clear guidelines and



policies on what is being allowed to be said and what not as there is nothing in place for now. If we go forward with this avenue, we need to have the mechanism in place in order to work on establishing these practices.

- Our FCAT Councillor mentioned that working on these guidelines would infringe the charter of rights and freedom specifically section 2B which is freedom of expression. So, do we have the authority to control the speech in council meetings.
- The VP Internal responded that they are not a human right lawyer or expert. But, this come backs to our bylaw 6-20 where we see if we have to restrict freedom of speech and when that gets cleared out we can see how to moderate this. In essence they feel they are not the only person to make guidelines on these and this should be passed on to the legal team. They will not be comfortable in writing something that restrict freedom of speech.
- The SASS Councillor mentioned that they agree with our SUS Councillor and at that time they did try to go on the website to find the report but the link was not working so they felt uncomfortable themselves and to blame our PSU Councillor that they are applying that indigenous community is fraudulent is not fair. They do not mean that and if it would have been the same with nay other organization where we donate the money. They should have the information on where the money goes.
- They mentioned that making one question about report or the organization makes someone racist or anti-indigenous. To blame solely on him is not fair considering they are not from this country and they are not so knowledgeable about the indigenous community. So, asking questions about this area is not allowed, is there any censorship in place, we should be able to ask question and not get trouble for it.
- It was a fair question and they asked it out of concern about where our money is going. \$10,000 is a lot of amount.
- The President reminded council to be mindful of the language they use while communicating.
- The SUS Councillor mentioned that they understand where everyone is coming from. On our end there was funding going out and information given to us was not enough to determine if the funding should go ahead to this organization. The sentiment was not that we did not want to donate but to have more information to make sure that the money is being used rightfully to make sure where the organization sits within the community. As long as we had reputable information about the organization that meeting they do not think any councillor would have had a problem to go ahead with the approval of this motion. They are not sure if any FNMISA councillor were sitting at that community.
- There was a severe lack of information for that motion. They mentioned that If any motion is coming forward for donations we need as much information as possible.
- The Acting GSSU Councillor mentioned that they came last meeting to ask the question to use restful use of council timing. They asked serious questions as to make



sure process is being followed before donating a large amount of money. They wanted to know if there are any paperwork's / due diligence done for any not just indigenous organizations.

- There question on why the money is increasing from \$6000 to \$10,000 was not answered.
- Also, they asked if we can also go into the SFU Community to directly benefit the indigenous community within SFU to help indigenous students align with our policy.
- So, nowhere in here anything racist was being said and our VP External were not able to answer these questions.
