

- The event will have check-in at 11:00 am to 11:45 am at the SUB Ballroom.
- The scavenger hunt will take place at 11:45 am 1:45 pm campus wide.
- The pizza lunch will be at SUB Ballroom for attendees and volunteers from 1:45 –
   2:45pm.
- The bouncy castles will be at central gym from 2:45 pm 4:45 pm.
- The dinner will take place at dining commons from 4:45 pm to 6:30 pm.
- The dance party will be held at SUB Ballroom from 6:30 pm to 8:30 pm.



- The overnight movie marathon will be held at the Images Theatre from 8:30 pm to overnight.
- There will be an activity room as an option outside of movie watching at AQ/RCB rooms from 8:30 pm to overnight.
- In terms of Finances: the merchandise will cost \$1532 (\$7.66 per person for 200 totes bags), pizza lunch will cost \$1750 for 58 pizzas, the bouncy castle costs \$2997, the dinner will come up to a cost of \$2970 (\$16.49 per person for 180 people).
- Ensure that all event leaders are explaining the rules and risks before each event, to ensure maximum safety.
- Ensure that there are first aid kits with each event leader, and that attendees are able to identify event leaders in the given circumstance (event leaders will have some sort of identification, whether it is a t-shirt or hat, etc.)
- CONTINGENCY PLAN: We will be overseeing proper event training with our volunteers to
  ensure that they know how to handle/de-escalate an injury case, and when to escalate
  to external help (police, or ER).
- Should the weather proceed to be unsafe for this event to take place; for example, heavy snow causing a hazard for attendees, volunteers, executives, and entertainment to drive up the mountain, which will be dangerous for events such as the campus-wide scavenger hunt, we will postpone the event.
- Event leaders/volunteers will be trained to look out for signs of an allergic reaction, and when to escalate and call for an ambulance.
- FASS Frenzy 2023, will provide a long overdue faculty-wide event for FASS students, that was previously unable to happen due to the COVID-19 pandemic.
- This event will allow first-year FASS students to engage and meet other students in the faculty, and even their intended major.
- Though our priority for this event is first-year students, this will provide a time for second-year and third-year students to socialize, as the COVID-19 pandemic restricted them from not only a FASS FROSH when they were in first-year, but in addition to their missed high school graduation, prom, winter formal, and more.
- Many second-year students, like myself, had an online hive group, and no frosh, so they still have a hard time making friends, even after a year of being at this school.
- This will jumpstart SFU student life through our school's biggest faculty, since the COVID-19 pandemic - No more "SFU is dead", "SFU has no student life", "SFU is a hard place to make friends" comments - this event will start to eliminate these stereotypes from SFU.
