# 6. PRESENTATION

# 6.1 CSSS SILICON VALLEY 2025

SUBMITTED BY: Computing Science Student Society PRESENTED BY: Computing Science Director of Events ATTACHMENTS: CSSS Silicon Valley 2024 Presentation

- Computing Science stated that a grant had been submitted on October 28, 2024.
- Operations Manager confirmed that a grant had been submitted by CSSS, and wondered if a recommendation was given.
  - Computing science mentioned that staff has not responded yet to the grant request.
  - Operations manager said that CSSS will not be able to go forward with the motion.
  - o President jumped in to say that CSSS will need to wait until the next council meeting to present because the motion cannot be voted on yet.
- Staff will need to approve grant request first, and if it is not enough funding, CSSS can go through an appeal process to receive more.
- Computing Science listed to ask why they had not received a recommendation as the

grant request was submitted over a month ago.

- o President responded that he will follow up with staff.
- O Staff mentioned that they will take a look at the grant as soon as possible.
- Geography listed to mention that council might have the authorization to approve the grant and questioned whether grant policies will be updated seeing as there are recurring issues with grants being delayed.
  - VP Internal responded to state that grant approved until the grant recommendations have been given by staff. So, the presentation and motion will need to be postponed.
  - o Operations manager clarified the grant recommendation and grant appeal process.
- Computing Science listed to state that the event will need funding soon due to time constraints and mentioned how a previous CSSS event received the grant recommendation in a council meeting.
  - Operations manager clarified that the grant for the previous event went through the regular approval process and an appeal was brought to council.
- President stated that the process to receive funding for this event will be expedited upon the next council meeting on January 10, 2025.
  - Computing Science stated that the date for the next official council meeting will delay event planning and questioned if council could vote on the grant approval.
  - President clarified that it would violate the process for the approval of grants since they would need to go through staff first.
  - President stated that the grant request amount was quite a large sum and will require approval from staff before being brough to council.
- President moved to postpone the presentation and motion to the next council meeting.
- VP Finance mentioned that the SFSS has funding guidelines that need to be abided by.
- ISSA listed to mention that the following week is still final exam period and that an emergency council meeting could be called just to approve the grant sooner.
  - President proposed calling an emergency meeting on Wednesday December 18,
     2024 to approve the grant but if quorum is not met, then this will have to be done on January 10, 2025.

# 8.1 Council Policy R-4 Changes - MOTION COUNCIL 2024-12-11:04

# **SUBMITTED BY: VP Internal**

# **President / VP Finance**

Whereas the Governance Committee approved minor changes to Council Policy: R-4: Stipends and Stipend Reduction Schedule;

Be it resolved Council approves striking the words "without approved regrets," from 4.11(a) & 4.11(b) in the Council Policies.

Be it further resolved to change R-6.9 to read "Regret' is a term that refers to a written document or electronic message submitted as a request to be excused from attending a meeting where attendance would otherwise be required. The primary purpose of regrets are as a mechanism to recognize situations where councillors have a valid reason not to be in attendance at a meeting and to not unduly penalize them under Bylaw 15 for their absence.

# Dissent: Psychology, ISSA, SASS, Philosophy, Data Science (5)

- VP Internal listed to offer a presentation on rethinking regrets.
  - o Discussed how there have been issues with meeting quorum.
  - o Stated that there is no effective system of policing regrets.
- VP Internal proposed to make changes to the policy concerning regrets, to narrow down the scope of regrets and increase engagement.
- Spoke about prioritizing council and meetings as being the most important part of being councillors and executives.
- VP Internal stated that these changes mean councillors will be fined for not attending meetings regardless of whether or not regrets have been submitted.
- VP Internal opened the floor to questions.
  - o ISSA questioned what the plan is regarding scheduling committee meetings during times when a councillor is unavailable.
  - President responded by stating that councillors are required to work with the executive in charge of the committee to accommodate the councillor's schedule.
  - VP Equity listed to build off of this comment to empathize with the councillors' concerns.
  - President clarified that if the committee meeting does not happen, the councillor or executive will not be fined for it.
- VP Internal clarified that regrets are meant to be used for special cases, not to have an excuse to miss meetings and still be paid for attending if they did not do so.
- President also clarified that regrets are not being removed completely.
- SASS listed to question if there is a review process for councillors who miss a meeting for a valid reason or if they will be automatically deducted.
  - President responded that it is an automatic deduction to the stipend for not attending a meeting.
- ISSA listed to state that councillors should not be deducted for missing a meeting since they are not being paid hourly but by stipend for the number of hours worked.
  - President reiterated that councillors will be fined for missing meetings since it is a part of the main responsibilities of councillors.
  - VP Internal responded as well to provide information on existing policies regarding deductions to pay.
- MBB listed to amend the policy to include request for regrets where the chair may have the ability to approve or deny regrets for meetings.
  - VP Internal responded that this system might be exploited, and the goal is not to police regrets. Therefore, making the specified change to the policy means that Executives are held to the same standard.
- ISSA listed to state that councillors should be paid for the reported hours of meetings attended to mitigate deductions if they still worked the 20 hours a week that are required.
- MBB listed to state that there should be a process to authenticate regrets, and whether it might be considered to include this in the process.
  - President clarified that the whole point of the new process is to create a standard that will apply equally to all members of the board.
  - VP Internal also responded that 4.11(a) refers to councillors and 4.11(b) refers to executives, and that meeting deductions for

councillors are only \$50 per meeting whereas for executives it would be \$100. So, executives are held to far larger fines for missing meetings.

- SASS listed to express disagreement with the proposed policy change because it penalizes councillors without offering substitutions and offered the example of sick days or paid leave.
  - VP Internal responded by mentioning that councillors at SFU are paid a substantial amount compared to councillors at other institutions.
  - o In terms of flexibility in the new system, it ensures that payment is made upon being present at meetings.
- Geography listed to agree with the proposed policy change because it encourages participation from councillors.
- SASS listed to mention that there are councillors who show up to meetings but do not participate at any point, and so the relevant groups still do not get the representation they deserve.
  - President responded that this policy is not specifically addressing active participation but rather attendance.
- VP External listed to mention that the proposed policy change is meant to clarify the process in terms of what regrets are used for.
- ISSA listed to state that councillors should be able to report the meetings they attend to be paid for the number of hours worked.
  - VP Internal responded that the new system has a benefit in ensuring that the meetings do not just accommodate the greatest number of members but rather ensure that all are present.
  - President clarified that council does not pay by the hour or by meetings attended because it is based off a stipend.
- VP Internal moved to amend the motion to include changes to R-6.9, VP Equity seconded.
- President mentioned that it is strongly encouraged to attend council and committee meetings as part of the responsibilities of councillors.

Whereas the Finance and Administrative Services Committee reviewed and approved changes to the Investment Policy on August 16 & November 22, 2024;

Whereas the Governance Committee also reviewed and approved the changes to the policy on November 25, 2024;

Be it resolved Council approves the changes outlined in the attachment "SFSS Investment Policy." **POSTPONED** 

- VP Finance clarified the changes being made to the policy, which include allocation of funds
  - o Included a change to tighten the policy to ensure that executives do not have access to funds for investment without consent from other board members.
  - o Met with Vancity manager to discuss their IP policy.

- Do not want to be directly or indirectly investing more than 5% into any investments that misalign with our IP policy.
- ISSA listed to ask for clarification regarding investments, and how Vancity is making investments that do not align with our IP policy.
  - o VP Finance responded that Vancity was further investing into Scotiabank which is one the 5 major banks we are trying to move away from. Which is why we are placing a cap on direct and indirect investments at 5%.
- VP External listed to state that he noticed the wording of the policy should be changed from "in alignment with..." to "not in alignment with..." regarding direct and indirect investments.
  - o VP External also added that the wording should state "up to 90%..." and recommended an amendment to the policy.
- President moved to postpone the motion with the condition that it goes to FASC and undergoes consultation before being brought to council. Seconded by VP Internal.
